1. Remuneration in respect of Data Entry Operators on contract basis will be paid as per Guidelines of Labour Department, Govt. of NCT of Delhi as per Minimum Wages Act.
2. The engagement will be purely on contract basis and it will confer no right to appointment or regularization and placement in Delhi Jal Board, or any ground whatsoever.
3. No other allowances or facilities, available to regular employees, shall be payable to person engaged on contract basis unless specifically agreed to.
4. The engagement on contract basis will be for a fixed period and shall automatically come to an end after the expiry of the stipulated period of contractual engagements.
5. The Department shall monitor the performance of the candidate so engaged and depending upon his/her performance further or fresh engagement shall be decided accordingly.
6. The engagement on contract basis can be terminated at any time without any notice.
