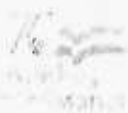

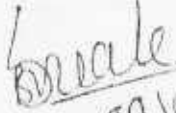
Subject :- Provisional Seniority List of Personal Assistants w.e.f. 01.01.2023 to as on.
