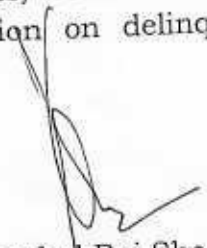
1. All EE Divisions to list Construction sites according to following criteria-

 - Construction Site-wise No. of deployed Anti-Smog Guns as per CAQM standards,
(5-10000 SqM- 1, 10-15000 SqM- 2, 15-20000 SqM- 3, >20000 SqM-4)
 - Construction Site wise No. of deployed Sprinklers.
3. List of all active Road Cuttings by DJB, AC, Ward, In-charge of work
(Name, Designation, Mobile number) as on 28-10-2025
 - Road Cuttings Site-wise No. of deployed Anti-Smog Guns,
 - Road Cuttings Site-wise No. of deployed Sprinklers.
4. AC-wise list of No. and Name of Roads that DJB owns outside DJB Campuses.
 - All Dusty patches, Potholes to be repaired on these Roads,
 - Side pavements of These Roads to be constructed and Greening to be done on sides and Central verge if Area too large for Paving,
 - Timeline for Above.
5. DJB Inside Campus wise List of No. and Name of Roads and Dusty Patches

6. No Wood/ Alow/ Paper/ Garbage Burning in DJB Campuses and DJB related any installations or Construction sites. Especially By Security Guards and Labours. It will be personal responsibility of EE of Campuses, Work sites.
