1. Subject to final outcome of Hon'ble court case(s), if any.
2. Officials promoted to the post of Junior Engineer (Civil)/(E&M) on regular basis are required to qualify the Accounts Test within a period of 02 years/ or until they are provided at least 04 chances from the date of their promotion so as to qualify themselves for the grant of further annual increments, successful completion of probation period, MACP and further promotion.
3. The promotion shall also be subject to verification of genuineness and authenticity of Educational/Technical Qualifications, Caste Certificate, etc. from the concerned Institution/Authority. The promotion shall remain subject to verification of valid technical qualification and the affiliation/recognition of the issuing Institute/University. In case any discrepancy or adverse entry is notice during such verification, the promotion shall be liable to be reviewed or withdrawn as per rules.
4. The promotion shall further be subject to verification of ACRs/APARs, Work & Conduct Report, Vigilance Clearance and other relevant service record.
5. All the Promoted JEs (Civil/E&M) shall submit a written undertaking (as enclosed herewith) declaring that if at any stage any adverse remarks are found during verification of ACRs/APARs, Work & Conduct Report, Vigilance Status, or verification of Diploma/Degree, the Competent Authority of the Delhi Jal Board shall have the right to revert him/her to his/her substantive post, and he/she shall have no objection to the same.

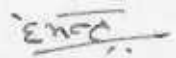
