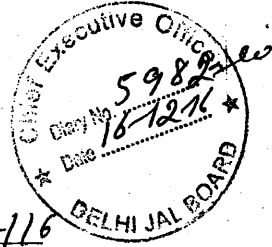

Sub:- Regarding sponsoring the names for appointment to the post of Superintending Engineer (Civil), Executive Engineer (Civil) & Asstt. Engineer (Civil) on deputation basis in the Delhi Agricultural Marketing Board.

Sir/Madam

I am directed to say that few posts of Superintending Engineer (Civil), Executive Engineer (Civil) & Asstt. Engineer (Civil) are vacant and required to be filled on deputation basis in Delhi Agricultural Marketing Board.

The eligibility conditions for deputation of above mentioned posts are as under:-

- i) **Superintending Engineer (Civil)**- Officer under the Govt./Govt. undertakings holding analogous post (pay scale of PB-3 Rs. Rs.15600-39100 + GP7600) OR with 5 years service in the posts in the rank of Executive Engineer or equivalent and possessing degree in Civil Engineering from a recognized university.
- ii) **Executive Engineer (Civil) - (a)** Officer holding analogous posts on regular basis (pay Scale of PB-3, Rs. 15600-39100 + GP 6600) or **(b)** with 5 years regular service in the grade in the pay scale of PB-3 Rs.15600-39100 + GP 5400 or **(c)** 8 years regular service in the grade in the pay scale of PB-2, Rs. 9300-34800 + GP 4600 and possessing degree in Civil Engineering.
- iii) **Assistant Engineer (Civil)** -Officers holding analogous posts on regular basis in the pay Scale of PB-2, Rs.9300-34800 + GP 4600 or 8 years regular service in the grade in the pay scale of PB-2, Rs. 9300-34800 + GP 4200 and diploma in Civil Engineering.

Since, the Delhi Agricultural Marketing Board is a body corporate and a local authority as per section 6 of the Delhi Agricultural Produce Marketing (Regulation) Act, 1998 and follows the Rules/Regulations/instructions of the Govt., the laid down terms and conditions of deputation of the Govt. shall be applicable to the officer on deputation basis.

It is therefore, requested that the names of suitable and willing officers along with their application, Bio-data, ACRs for the preceding five years, Integrity Certificate, vigilance clearance and cadre clearance etc may kindly be forwarded, to enable us to consider selection for appointment to the above said posts on deputation basis.
