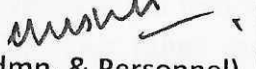

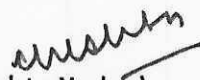

Serving officers who possess the eligibility conditions prescribed in the vacancy notice may apply through proper channel upto the extended date of receipt of application till 12.01.2024 on offline mode in prescribed format as per Annexure-1 to the notice, along with duly certified photocopies of the ACRs/APARs for the last five (5) years to the office of the Director (A&P), Room No. 202, 2nd Floor, Varunalaya Phase-II, Karol Bagh, New Delhi-110005.
3. **Age Limit:** The maximum age for appointment on deputation shall not exceed fifty-six (56) years as on the closing date of receipt of the applications.

 - 4.1 The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in other Organization or Department of the Central Government shall ordinarily not exceed five years.
