TERMS AND CONDITION FOR SUPPLY OF SLUDGE GAS (PROVISIONAL)

1. Sludge Gas shall be supplied to the consumers at the rate of Rs. 100/- (Rupees One Hundred) per 1000 Cu. Ft. (28.317) Cum. Gas consumed through the Gas meters. The rates will be subject to revision by the Component

Authority and shall be binding on the consumers. E.D. & S.T. as applicable shall be charged.

- 2. In case of meters not installed a flat of Rs. 100/- per month per connection shall be charged for General Public and Rs. 50/- per month per connection for staff residing in Departmental Accommodation. (This is as per D.J.B. Resolation No. DJB/DOR(W)/B.Gas/HC/98/3529 Dt. 21.9.98. Rates shall be subject to revision as at (10 above. E.I. & S.T. as applicable shall be charged extra.
- 3. The consumer shall have to deposit Rs. 300/- as Security (Re-fundable) after surrender of the Gas Connection etc. The amount of Security will be deposited by the form of Bank Draft or in Cash. Bank Draft may be drawn in the favour of Chief Engineer (W) DJB or the Cash may be deposited in the Office of Zonal Revenue Officer (W) Jal Sadan Lajpat Jagar-II, New Delhi-24, Canteen owners shall have to deposit Rs. 1000/- for each Canteen connections towards Security. Bulk Consumers will also have to pay Rs. 1000/- per connection as Security deposit.
- 4. The consumer shall have to deposit the cost of G.I. Fitting Pipe lines, meters, valves etc. and other fittings installed in his p-remises for gas connection including the labour charges. For this an estimate will be framed by the Department as per site requirement. The cost of above as per estimate shall have to be deposited plus 23.75% over head charges by the consumers through Bank Draft in the favour of Chief Engineer (W) DJB or in Cash may be deposited in the Office of Zonal Revenue Officer (W) Jal Sadan Lajpat Nagar-II, New Delhi-24.
- 5. For laying pipe lines and fittings etc. within the premise of the consumers whatever trenches dug, holes, are cut in the wall/Floor and other similar works, their reinstatement will be the responsibility of the consumers. The estimate as above shall not include such items.
- 6. The meters inlet connection service pipes and such other D.J.B. property shall not be handled by any other person other than an authorized Board Official. A penalty of Rs. 100/- shall be imposed for breach of this condition. If the penalty is not paid within 15 day of the date of issue of notice the gas supply to the consumer will be disconnected and will be restored only after the payment of penalty and dues if any. In case of repeated defaults his gas connection shall be disallowed on permanent basis.
- 7. The D.J.B. Board shall not be held responsible for any loss or damage to the gas fittings, Pipe lines and loss of gas beyond the meter outlet caused due to consequents arising from the lapses of property owner any other person or due to such any other reason.
- 8. The consumer shall be liable for making good any loss-es or damage to the meters, inlet connections pipe, line and any other D.J.B. property within the premises of the consumer caused by accident or due to such any other reason.
- 9. The regarding as shown by the meter installed shall be accepted by the consumer as correct and binding.
- 10. If ay defect or leakage in the gas service connection are noticed by the consumer it shall be his duty to inform the gas maintenance staff Okhla Sewage Treatment Plant Mathura Road N. Delhi-110020. Phone No. 6311963.
- 11. The DJ Board Staff appointed for maintenance having Identity Card Only shall have the right to enter the premises of the consumer at any time for the purpose of meter reading, inspection of gas fittings, attending to defects or carrying away the Board property when the gas supply disconnected.
- 12. The Delhi Jal Board not be responsible for any loss or inconvenience to the consumer arising from stopage of gas supply due to strike, fire or break down of gas plant or due to such other reasons which are beyond the control of DJB.
- 13. The gas supply connection shall not be transferred or extended to any new consumer by the existing consumer without sanction of the competent authority failing which the supply shall be disconnected and security deposit shall be forfeited.

- 14. The consumer will be charged for gas supply according to the rates fixed by the competent authority as at (1) and (2) above. Billing shall be monthly/ Bio-monthly/ quarterly.
- 15. If the bills are not paid during the prescribed time limit as above a penalty of Rs. 1/- per day shall have to be the deposit alongwith the bills. In any case the gas supply bills will be accepted upto the last date of the month thereafter the gas supply shall be disconnected without notice and the security deposite forfeited. the gas connection shall be restored on request after fresh security deposit and paying of previous bills with panelty to the department.
- 16. The consumer will have to make arrangement for burner at his own cost. However the design and make of Burner installed will be according to the list of manufacturers approved by the department.
- 17. Whenever meters are installed a meter rent @Rs. 2/- P.M. for domestic and meter rent of Rs. 10/- P.M. for bulk consumer shall be charged.
- 18. After the meteres have been installed and in case of any meter is not recording the consumption of gas, bill charged for that period shall be calculated on the average of the previous six months and or the subsequent two months consumption in the absence of previous consumption period.
- 19. The consumer shall point out to the Board any defects or leakage in the gas service connections belonging to the consumers. The Board shall carry out the repairs at the consumers cost to remedy the defects and leakage. until such time as the defective points shall be out as measures of safety. The consumers shall not be entitled to claim any damages or compensation for such period till the supply is restored.
- 20 The Board property shall not be mortage or attached by the consumer or the land lord.
- 21. if owing to shortage of gas or due to any other cause the gas supply is suspended by the Board for one more calendar months continuously, then no gas meter rent will be charged for the period i.e. for the complete month or months comprising the period of such Stopage of Gas.
