Sub:- Empanelment of Pvt. Hospitals for Providing Credit Medical Facilities to DJB Beneficiaries.

In supersession of this office order no. 08 dated 01.04.2024, the Competent Authority, C.E.O., DJB vide his order dated 23.03.2026, has accorded approval for Renewal / Empanelment of Private Hospitals for Credit Medical Facilities to Delhi Jal Board beneficiaries in emergency cases of Heart, Brain and Accidental Surgeries only as per **Annexure 'A' with effect from 01.04.2026** on the following terms & conditions:-

1. These Hospitals will provide credit medical treatment to the Delhi Jal Board Employees / Pensioners / Family Pensioners and their dependent family members strictly as per latest CGHS rate list /status of NABH/NABL as issued by CGHS or rate list of Hospitals, whichever is less.
2. Cashless treatment will only be taken from these hospitals only in case of medical emergency and not as a routine manner.
3. In general/routine for availing cashless facility from panel hospital, referral from departmental Doctor is mandatory and that too only in respect of diseases as specified above for indoor treatment and not for O.P.D.
4. At the time of admission in the hospital for cashless treatment of employees/ Pensioner/Family Pensioners must intimate his/her basic pay / pension, name and complete correspondence address of office from where he /she is taking medical reimbursement, his/her ward entitlement (General/Semi Private/Private) and his/her present complete residential address including Phone Number and Photocopy of his /her medical card etc. to the hospital.
5. At the time of submission of claim of cashless treatment to the concerned office of Delhi Jal Board, hospital concerned is required to furnish following documents:-
A) Photocopy of valid DJBEHS card of the beneficiary.

- B) Referral/authorization from AMA or emergency certificate issue by hospital concerned, as the case may be,
- C) Essentiality certificate 'B' as per CS (MA) Rules.
- D) Certificate by the hospital to the effect that :-
 - i) The treatment given by the hospital has been as per the entitlement of the beneficiary and the rates/ charges levied are as per CGHS approved rates.
 - ii) The treatment given was absolutely essential and in accordance with CS (MA) Rules and was not cosmetic in nature.
- 6. Stickers/invoices indicating Serial no/ Manufacturer etc. of implants etc. as per practice being followed under CGHS.
- 7. The bill should be as per package deal rates or item wise (if not included under package deal rates of CGHS) and should be authenticated / verified by the beneficiary or in case of inability/death of patient, the bills should be authenticated/verified by the next of kin/legal heir of the beneficiary or the attendant of the beneficiary.
- 8. Follow-up treatment subsequent to any emergent treatment/procedure or for the illness shall be on authorization of concerned AMA, (MOI of DJB).
- 9. The bills shall be submitted by the hospitals in such cases to the concerned department (where employee is serving) for making payments.
- 10. All cases will be examined by the Medical Screening Committee and only after recommendation by the MSC and after concurrence of the Accounts, the payment will be released to the hospital concerned by the concerned DDO of Delhi Jal Board within 15 days from the dates of the file is sent to DDO by the Labour Welfare Office. The recommendations of the Medical Screening Committee shall be final.
- 11. In case of direct admission on the pretext of medical emergency, the DDO concerned will issue referral letter to the hospital only after verifying that whether the disease for which the beneficiary has been admitted in emergency covers under the specified disease (**Heart, Brain and Accidental Surgeries**) as mentioned above or not. In case it is found that the disease for which the beneficiary has been admitted in panel hospital does not cover under the specified diseases, referral letter should not issued by the DDO.

12. All the heads of Divisional Offices are advised to ensure that the reimbursement especially in case of credit facility is sanctioned well in time. The expenditure incurred on credit, in terms of contract entered into with the hospitals must be paid within 60 days of the submission of the bills by the hospitals.
13. Other guidelines for availing medical treatment from Hospitals issued from time to time by Delhi Jal Board shall be adhered to.

All Drawing and Disbursing Officers (DDOs) and Medical Officers-in-Charge (MOIs) are directed to update their records immediately.
