

Registration of Water Tanker Vehicles

National Green Tribunal has issued directions on 03.09.2013 in application no. 108 / 2013 National Green Tribunal Bar association V/s NCT of Delhi and others to prevent unauthorized and illegal use of ground water.

The Committee constituted by National Green Tribunal has decided that all the water tankers supplying water for potable / non potable purposes shall get themselves registered with Delhi Jal Board. All the owners of the water tanker vehicles were directed to apply to Executive Engineer (Ground Water Cell / RWH) Room No. 11, Varunalaya Phase-I, Karol Bagh, New Delhi-110005 within 30 days of the publication of the notice (Published on 14.12.2013 in leading news papers in Delhi) and as extended from time to time in the format available on DJB website (www.delhijalboard.nic.in) along with the requisite documents duly attested and payment of registration fee of Rs. 1,000/- per water tanker vehicles through Demand draft / cheque drawn in favour of Delhi Jal Board.

Delhi Police and Transport Department will ensure that no water tanker without authorization / registration with DJB will be allowed to operate within NCT of Delhi.

Public notice along with application format is available on DJB website www.delhijalboard.nic.in (Home>information>News>S. No. 106 Authorization/Registration of water tanker Vehicles in DJB).

Application form with registration fee of Rs. 1000/- per water tanker vehicle is to be submitted along with attested copy of following documents:

1. Registration, fitness and pollution under control certificates of the vehicles.
2. Valid permits for plying of the vehicles in NCT of Delhi for non Delhi registered vehicles.
3. Documents regarding hiring of water tanker vehicles and delivery point from the recipient of water.
4. Document in support of permission for filling water tanker from the authorized owner of the water source mentioned in the application.

It is undertaken that:

1. I will fulfill all the conditions for plying of this vehicle in Delhi as stipulated by the Department of Transport, GNCTD.
2. I agree to install a GPS unit as approved by DJB in my vehicle at my own cost and will not have any objection to the monitoring of the movement of the vehicle. I will also be responsible for keeping the GPS functional at all times.
3. I will send the vehicle for inspection as and when ordered by the authorities at a notice of 48 hours.
4. Efficient fixtures will be installed in the vehicle to ensure that water does not spill / leak during movement.
5. I will fully abide by all the directions issued by DJB from time-to-time regarding operation of the water tankers in the city of Delhi.
