The work of installation of flow meter at the inlet of 900mm Dia. Narela UGR is proposed to take up on 05.01.2024 from 10:00 AM to 10:00 PM. Therefore, water supply will not be available on 05.01.2024 or may be available at very low pressure.

The following areas likely to be affected are:-

Singhu, Singola, Khampur, Bakoli, Hamidpur, Swarn Jayanti Vihar, Tikri Khurd Villages and their adjoining areas.
