The information was apprised to the Board as contained in letter No. DJB CE(WW)/2021/11 dated 25.10.2021 of CE(WW)that the lowest bid has been found to be eligible on the basis of just one experience certificate uploaded in tender documents without considering other documents which were got verified later. Member (F) reiterated the observations of finance wing

After deliberating the findings of the Work Advisory Committee, the Board accorded administrative approval of the lowest offer of M/s AGS Infra Projects Pvt. Ltd. at a total cost of Rs.28,67,55,000/- (Rs. Twenty Eight Crore Sixty Seven Lakh Fifty Five Thousand Only) against departmental justification of Rs.33,92,76,936/- for comprehensive O&M of Pkg.1-A and Pkg.-3 of DWSS scheme for 5 years period.

The Board also resolved to take further action in anticipation of confirmation of the minutes.

# RESOLUTION NO. 1203: (ON TABLE – No item available) Suo-motto resolutions/ decisions taken in the meeting:

- The Board resolved that all cases in Vigilance Brach, as on date should be disposed off by 31.03.2022. For the cases registered, thereafter, the investigation should be completed within a period of six months.
- 2. It is directed that in the cases of registered contractors who have technically qualified once, their assessment should not be done for each tender, during the validity of registration.
- 3. It is also directed that there will be two offices i.e. Chief Engineers and Addl. Chief Engineers. The staff working under them will be known by the name of these offices.
- 4. Posting of AE or JE and other staff posted underzonal addl. Chief Engineer can be made by concerned Addl. Chief Engineer under his/her jurisdiction with a copy to

Administration.

- 5. The Board further directed that in future all the sewer line manholes should be of precast concrete in place of brick masonry chambers, wherever feasible. Minimum size of sewer should be 300mm dia in place of 250mm dia considering future increase of population in Delhi. The present cost of change in size from 250 to 300mm dia is nominal as compared to cost of replacement in future. The Board further resolved to accord in-principle approval of variation in cost on these account, if any.
- 6. While calling the tendersof Sewage/ Water lines related works, period of completion should be less than one year (excluding monsoon season). For provision of more than 1 years, approval of Chairman, DJB would be required. For Provision of Incentive and/ or Penalty clause should be there in the NIT.
- 7. Board further fixed accountability of CE/ACE on assessing actual requirement of pipeline dia against proposed dia. under SMP 2031 as it has been observed that recommendations of SMP-2031 are generally found inadequate in the field in many cases.
- 8. Board further directed DJB officials that for any tender, technical responsive bid should be automatically considered as empanelled for tenders in next 2 yearsfor similar worksand only financial bid be evaluated in next tenders. For new bidders, technical bid should be evaluated as well
