#### **CONFIRMATION OF MINUTES**

Minutes of 164<sup>th</sup> meeting of the Board held on 11.01.2023 were confirmed. It was discussed that DDA did not issue the NOC to DJB for installation of Tube wells. Therefore, Board directed that the implementation of resolution Nos. 1329, 1330, 1331& 1333 be kept on hold. CEO, DJB informed to Board that in these items action has already been taken and DDA has also deposited the payment. Hon'ble Chairman directed to refund the amount, if required as DDA is not cooperating in issuing the NOC for Tube Wells of DJB. For resolution No.1326 Board directed that the National Productivity Council be directed to submit a presentation for improvement of performance/productivity in DJB.

#### **ACTION TAKEN NOTE**

The action taken notes in respect of the decisions taken in  $164^{\text{th}}$  meeting of the Board held on 11.01.2023 were placed before the Board, and the same was taken on record.

## ITEM NO. ADMN.-627Revised Budget Estimates for the year 2022-23 and BudgetEstimates for the year 2023-24

The Board considered the proposal contained in proposal DJB/Dir.(F&A)/B&A/2023/1549 dated 24-04-2023 of Director (F&A)and resolved to approve the Revised Budget Estimates for the year 2022-23 and Budget Estimates for the F.Y. 2023-24 enabling the discharge of responsibilities and to meet out all essential expenditure during 2022-23 (RE) and 2023-24 (BE) on ongoing projects, undischarged liabilities and new projects including the establishment expenditure for all categories of staff. The Board also resolved to approve bulk final collecting rate of water, the disposal rate of sewerage for 2021-22, estimated collected rate of water and disposal rate of sewerage for 2022-23(RE) and 2023-24 (BE) at which NDMC and MES shall be billed.

M(A) informed that 10 number of posts are deliberately kept vacant in order to accommodate retired Executive Engineers. Chairman, DJB showed displeasure and instructed to the fill the vacant post immediately with regular candidates of DJB

The Board considered the proposal contained in proposal No. DJB/Dir.(A&P)/AC(T)/ 2023/788 dated 02-05-2023 of Director (A&P) and approved the proposal regarding review of Office Order No.238 dated 03.12.2021 issued in pursuance of Resolution No.1206 approved under Minutes of 159<sup>th</sup> Board Meeting held on 22.11.2021. Accordingly, the following resolution was passed:

The Board considered the proposal contained in proposal No. DJB/Dir.(A&P)/(T)/2023/ 790dated 03-05-2023 of Dir.(A&P) and resolved to accord ex-post-facto approval for Continuation of appointment of Sh. Vinod Kumar, Consultant (GIS) and Syed Tauseef Hussain, Consultant (Sewage) on contract basis for further period of one year w.e.f. 13.01.2023 to 12.01.2024 with enhancement in their monthly remuneration.

## RESOLUTION NO. 1348 ITEM NO. ADMN.- 635 Reporting hierarchy in respect of Addl. Chief Engineer (Maintenance) of DJB

The Board considered the proposal contained in proposal No. DJB/Dir.(A&P)/(T)/2023/791dated 03-05-2023 of Dir. (A&P) and resolved to defer the proposal for reporting of ACE(M) to Chief Engineer concerned.

## RESOLUTION NO. 1349 ITEM NO. ADMN.- 636 - LPSC and Bill Recasting Scheme 2023

The Board considered the proposal contained in proposal No. DJB/Dir. (Rev.)/ LPSC & recasting scheme/2023/250 dated 03.05.2023 of Director (Revenue) and resolved to approve the proposal of LPSC and bill recasting scheme with the modification in the conditions (i) that the benefit of the scheme be given to those consumers also who have never paid in the last 11 years i.e. from July, 2012. (ii) that the cases where value/average is below 0.5 times of the median value be included in the Scheme.CEO, DJB stated that he was of the view that consumers who are habitual defaulters for the last 11 year and did not make payment should not be included in the Proposed Scheme. This will defeat the purpose of the Scheme of recasting the bills. Further, Member (Finance) submitted that it would not be appropriate to include the above category of consumers in the benefit. This would lead to further huge financial implications. Moreover, the consumers who did not pay any amount in the last 11 years even did not avail the Amnesty Scheme of DJB, are supposed to be wilful defaulter and do not want to pay water utility bills. Hon'ble Chairman, DJB stated that this is not a Amnesty Scheme and it is a way to reduce the grievances of wrong billing/higher billing, therefore, it is not appropriate to say that this would lead to huge financial implications.

Further, Member(Finance) has submitted her dissent note dated 14.06.2023 which is reproduced as under:

"Following observations were submitted to the Board by the undersigned regarding the scheme:

1. This scheme was announced in Jan.,2023 when the earlier LPSC waiver scheme was operational which affected the revenue collection during that scheme and since then, the revenue receipts from domestic consumers have gone down with the announcements regarding OTS. (LPSC Waiver Scheme revenue collection dipped from January, 2023 onwards as the collections were approx. Rs.13 cr for Oct'22 (half month), Rs.53 cr for Nov'22, Rs.202 cr for Dec'22, Rs.31 cr for Jan'23, Rs.18 cr for Feb'23 and Rs.44 cr for Mar'23) As such, no announcement of the scheme be made for the public till the time it is approved by the competent authority in GNCTD.

- 2. Such schemes lead to moral hazard and consumers tend to get habituated to not paying and waiting for similar amnesty scheme.
- 3. Currently, the scheme is for domestic consumers and it may lead to demands from commercial consumers as well.
- 4. DJB is an Autonomous body and due to lack of sufficient revenues, is dependent on GNCTD and such a scheme would increase the dependence on outside sources of loan/grants and move away from the goal of becoming truly self-Revenue receipts are only around 65% of the Total operating expenditure and DJB is dependent on ways and means advance of around Rs. 900 cr. Per annum from GNCTD to meet operational expenditure.

In addition to the dissent to the scheme as above, the undersigned humbly submits the following dissent to the following changes which have been proposed by the Hon'ble Chairman:

The scheme was earlier proposed as a bill recasting scheme to cater to the grievances of the consumers regarding billing not being aligned to the actual consumption of the consumers with a lot of cases pertaining to COVID period when actual consumption was not taken or billing was done on average basis due to meter stop cases, etc.

Addressing the dissent raised by Member (Finance) with respect to "item no. ADMN. 636: LPSC and Bill Recasting Scheme 2023", Chairman, DJB explained

The problem of unreasonably high-water bills of DJB has been a serious concern of the people of Delhi for many years now. In fact, the concern is so widespread that it has not only been brought up in almost all meetings of the Elected Representatives with the Revenue Department, DJB but also discussed in most of the public forum hosted by elected representatives of the Delhi.

Thus, when in January,2023 Hon'ble Deputy Chief Minister, Manish Sisodia Ji called for a meeting on the issue, it was highlighted that consumers are very agitated because of the slow and inefficient resolution of the Consumer Billing Grievances at DJB ZRO offices.

The consumer redressal mechanism at the DJB ZROs is very cumbersome. As per a calculation of the DJB Revenue Department in the past 8 months, only 8,000 deletions have been undertaken in 42 DJB zones in Delhi, resulting in an average of <1 consumer grievance redressals per ZRO per day. If continued with the same rate, DJB will be able resolve pending complaints of 11.71 Lakh consumer in $\sim$ 100 years.

I have myself seen many complaints with evidence, wherein our meter readers have not entered the actual meter readings. Consequently, consumers complained of discrepancies in bills. However, despite discussing this matter multiple times with the Vigilance Department, GNCTD no concrete action has been taken against the wrongdoers. However, in the ongoing concern neither Govt. of the NCT of Delhi nor DJB should penalize the consumers for the wrongdoings of the staff of the Revenue Department, DJB

It is noteworthy that in January 2023, DJB announced an LPSC Waiver Scheme conceptualized by the CEO, DJB and Member (Finance). Through this scheme the then Member (Finance) herself approved the waive off of Rs.2,266 crores of LPSC. Thus, her current dissent to continue with this LPSC waiver, initially proposed by the Department, for the One-Time Settlement (OTS) Scheme seems contradictory. Moreover, it may be noted that the OTS Scheme is not a waiver scheme and does not promote to write off Rs.123 crores of principal amount. The OTS Scheme intends to give a one-time offer to all its beneficiaries to settle their previous pending and inflated bills. This one-time offer uses the past water consumption pattern of each consumer to provide a fair and just tailor-made solution by extrapolating the consumers average consumption for the total unpaid period.

DJB currently has 27.61 Lakh consumers spread across 42 zones of which  $\sim \! 10\%$  (2 Lakh) consumers have not paid in the last 11 years. The OTS Scheme may incentivize these consumers to resolve their pending bills and continue with correct payment behavior in future. However, there is a high chance that many of them do not avail the offered One-Time Settlement amount as well. In that case, this offer will expire as per the guidelines of the schemes and these consumers shall be again liable to pay their original demand bill amount. Hence, the dissent in this regard too offers no basis to suggest that the change in the scheme requires a write off Rs.123 crores.

Furthermore, through this offer if even a miniscule percentage of this category of consumers resolves its arrears, it will only add to the revenue of DJB. DJB stands to

only gain from the above proposition!

Majority of the consumer grievances is because of the well accepted fact that the meter readers did not record the actual meter readings. These meter readers did not undertake their duty of responsibly visiting the premises and capturing the correct meter readings. But instead created fictitious readings which resulted in consumers receiving arbitrary and unreasonable bills. The consumers cannot be penalized for irregularities done by DJB staff and lack of supervision by Senior Officers of Revenue and Vigilance Department. It may be noted that the DJB has long since been using a process wherein readings above 1.5 times are scrutinized for any unwanted system irregularities. Thus, suggesting changes in the meter readings upto 1.5 times are normal and accepted. This mechanism also suggests that any decline in the meter readings without any measurable threshold is also normal and accepted. A decline in the meter reading can be attributed to natural life changes such as certain members of the household left for jobs, wedding, death etc. In the revised scheme, the threshold has been revised to 2 times the median reading. As such, the consumer has to already bear the additional cost of the increased threshold. It is against the vision of the Govt. of the NCT of Delhi to further penalize the consumers by even taking away the readings below 0.5 times the median. As such, the dissent raised by the Member (Finance) in this regard is also unnecessary and unwarranted.

Board further directed that it may be apprised in the next meeting of the Boardregarding action taken for debarring contractor due to poor performance.

Project.-I/2023/01 dated 02.05.2023 of Chief Engineer (DR.)Proj-I and it was discussed that there is financial crunch in the department, therefore, it would be appropriate to defer the proposal for award of work till the confirmation of funds under "AMRUT" 2.0 Scheme.

#### **RESOLUTION NO. 1363**

ITEM NO. T-431 - Providing & Laying 300mm to 900mm nominal dia internal and peripheral sewer line in Shri Ram Colony, Rajiv Nagar and part of Sonia Vihar in Karawal Nagar, Delhi

The Board considered the proposal contained in Preamble No.DJB/CE(DR.)Proj.-III/2023/03 dated 02.05.2023 of Chief Engineer (DR.)Proj-III and it was discussed that there is financial crunch in the department, therefore, it would be appropriate to defer the proposal for award of work till the confirmation of funds under "AMRUT" 2.0 Scheme.

## ITEM No.1 CHAIRMAN-Transfer & Posting of Officers/Officials of DJB.

The Board considered the proposal and resolved to approve that a Committee of the following is constituted for transfer and posting among all categories of officers including and above the rank of Superintending Engineer/Director and its equivalent designations in any Department/Division etc. (by whatever designation it may be called) in DJB:

(i) Minister Incharge of Water (DJB)

(ii) Vice Chairman, DJB

(iii) CEO, DJB

- Chairman

Member

Member Secretary

In so far as the transfer/posting of officers/officials who are not covered in above para are concerned, the concerned Member/CVO/Secretary or equivalent officers (by whatever designation it may be called) shall be the Competent Authority for the same.

After discussion it was decided that the work allocation will be decided by the Controlling Officer concerned. If transfer/posting falls across the domain of the Member/CVO/Secretary or equivalent officers (by whatever designation it may be called), the same may be done by above mentioned Committee.

In the interest of efficiency, efficacy, transparent administrative functioning and ensuring best services to the people of Delhi, the aforementioned policy of transfer, posting and allocation of work/additional work, shall be operational in normal circumstances and can be modified/ dispensed with by the Board, at any juncture.

C.E.O., DJB submitted that it would be appropriate to decide this issue before the regular C.E.O. in the next Board Meeting.He further submitted that the proposed agenda would dilute the powers of the CEO who is the Head of the Department and always represent the department before the public. It would also dilute the chain of command which would affect adversely the administrative work of the department. Therefore, it is not advisory to dilute the command of the CEO. By making transfer by the proposed committee of members,Inter-department/Wing transfers would be difficult. He also expressed that political representativesshould not be involved in the transfer/posting in the department as it becomes difficult for political representatives to say 'No' to external persons. CEO expressed his dissent for the proposal.Member(Admn) and Member(Finance) submitted their dissent on the proposal.

Member(Admn.) has expressed certain reservations regarding this agenda item in his written dissent note dated 19.06.2023 which is as under:

"He submitted before the Board that there would be various problems with regard to implementation of the proposed delegation of power with respect to Transfer and Posting of Officers. He specifically pointed out regarding problems in respect of inter-departmental transfers in this regard. He further submitted that under the statutory provisions of the Delhi Water Board Act, 1998, one of the Members of the Board has been designated as Member (Administration), who would be a Senior Government Officer having specialized knowledge and practical experience of Personnel and Administrative matters. The work of transfer and posting of officers/officials pertains to the Personnel and Administrative domain and, therefore, the same should not be assigned to other Members having specialized domain knowledge in some other fields. This arrangement would be contrary to the provisions of general administration envisaged in the Act."

Chairman, DJB explained to the Board that, it is very clear from the DJB Act and Resolution no. 1 of the first board meeting dated 17.04.1998 that all powers of transfer and posting were vested with the Board which were subsequently delegated to certain officers. Thereafter, there have been many orders/resolutions to regulate these powers. Recently, as per ORDER no. 77 issued vide office order no. D-1542 dated 26.08.2022 signed by CEO, DJB Mr. P.Krishnamurthy stated that "transfer/posting proposals of all categories of officers/officials shall put up to the CEO for consideration and approval". After this order transfer posting of all the employees of DJB from Class 1 to Class 4 was being done after approval of single official i.e. CEO, DJB. Further, through another order no. 80 issued by CEO, previous ORDER no. 77 issued wide office order no. D-1542 dated 26.08.2022 was withdrawn. DJB is a public service department catering to almost every Delhi resident. There are multiple reasons when efficient working of Department is dependent on appropriate officers who are technically better suited considering need of the work. When all transfer/posting in DJB are to be decided by a single officer in the DJB, it leads to bottleneck in the efficient working of the Department. DJB is supposed to be a very agile and dynamic department wherein decisions should be reasonable and swift. Most importantly, it is a technical member who knows best about the requirement of best suited Engineer for a particular type of project or task. Thus, in order to make DJB more efficient and swifter, transfer /posting of the lower levels officers should rest with concerned Member(s).

Chairman, DJB also observed that in the draft minutes of meeting forwarded by CEO,DJB it is mentioned that Member (Finance) has dissented with the proposal. In this regard Chairman, DJB has opined that Member (Finance) as an afterthought is placing a new dissent regarding policy of transfer postings in DJB because no such dissent was raised by her during the Board Meeting. The video recording of the same is available and Member (Finance) is advised to avoid such afterthoughts in future.

# ITEM No.2CHAIRMAN -Policy for Ad-hoc Promotion and also for entrustment of Current Duty Charge/Look After Charge on completion of 2/3<sup>rd</sup> of qualifying service.

The Board considered the proposal and it was decided with the consensus of all Members that DoPT Guidelines should be followed in granting the Ad-hoc Promotion. Therefore, it was decided that till the further decision of the Board, the existing policy as per DoPT guidelines and as approved by the Board in its 164<sup>th</sup> meeting dated 11.01.2023for Ad-hoc Promotion be continued, hence this item was treated as withdrawn. However, for CDC/Look After Charge the department may take judicious decision as per functional requirement in the department.

It was also decided by the Board that a report be submitted within one (01) month with the reasons for non-conducting the DPCs/ non-granting the promotions in respect of all pending promotions and also submit the solutions to resolve the issues in granting the promotions for smooth functioning of the department. After submitting this report such report be submitted quarterly.

ITEM No.3 CHAIRMAN -Engagement of Law Firm for the projectscosting
10 crores &above at the time of draft NIT and
Extension of Time"/EOT in all on-going as well
future works in the cases where time has exceeded
1/3<sup>rd</sup> of the original project completion period should
be issued by the competent authority after approval
from Chairperson, DJB.

The Board considered the proposal contained in Resolution No.1365 and resolved to approve that:

- (i) In supersession of earlier orders/circulars/Board resolution, legal firm be engaged in all the projects costing 10 crores and above. The legal firm will be engaged from DJB side at the time of Draft NIT. All communications between the DJB and the contractor will be legally vetted to protect the interest of DJB.
- (ii) In supersession of earlier orders/circulars/Board resolution,approval of final Extension of Time"/EOT in all on-going as well future works costing more than one crore where time isexceeded 1/3<sup>rd</sup> of the original project completion period be issued by the competent authority after approval from Chairperson, DJB.

During the discussion it was also decided by the Board that a review meeting every six months would be held to review the Performance of Contractors and for taking necessary action against the default contractors.

The meeting ended with a vote of thanks to the Chair.
