The engagement shall be on a contract basis through e-tendering, initially for a period of 365 days with an estimated financial implication of Rs. 1,64,10,39,946/-

The Proposal contained in the Preamble No. DJB/DIR.(A&P)2025/814 of Director (A & P) was placed before the Board and Board resolved to approve the same.

The Board considered the proposal contained in proposal No. C.E.(DR) PR-I/2025/13 dated 12.11.2025 of C.E.(DR)Project-I and after deliberation on the issue, Board resolved to approve the proposal.

The above said proposal contained in the Preamble No. CE(DR)PR-I/2025/15 dated 12.11.2025 was placed before the Board. After considering the proposal, the Board resolved to approve the same.

RESOLUTION NO.1525

ITEM NO. T-520:- Construction of 1.5 MGD Sewage Treatment Plant (STP) alongwith associated/ allied appurtenant work on Design, Built and Operate (DBO) basis including 15 years O&M at Bijwasan.

CE(Dr.)Pr.-I briefed the above said proposal as contained in Preamble No. DJB/C.E.(DR) PR-I/2025/16 before the Board and after deliberation on the issue, the Board resolved to approve the same.

RESOLUTION NO.1526

ITEM NO. T-521:- Providing & Laying 300 mm to 1200 mm nominal dia internal and peripheral sewer line for the work of Mahipalpur GOC under Bijwasan constituency and Construction of 6 MGD Sewerage Treatment Plant (STP) along with associated/ allied appurtenant work on Design, Built and Operate (DBO) basis including 15 years O&M at Rangpuri.

The above said proposal contained in the Preamble No. CE(DR)PR-I/2025/17 dated 12.11.2025 was placed before the Board. After consideration of the proposal, the Board resolved to approve the same.

RESOLUTION NO.1527

ITEM NO. T-522(On Table):- Improvement of Water Supply System including Operation and Maintenance of Transmission & Distribution Pipes, Pumping Stations, Service Connections and Consumer Meters with DMA formation and NRW Reduction in Chandrawal WTP Command Area, Package - 3 (Central).

It was discussed that the Proposal contained in Preamble No. C.E.(W) PR-II/2025/P-11was earlier placed before the Board in its 172nd meeting vide Resolution no. 1444, Item No. T-468, wherein Board was agreed with the proposal however the project cost escalated therefore, the Board recommended that concurrence of Competent Authority for this scale of project be first obtained then it should be put up before the Board. Now, CE(W)Pr-II informed that the approval of Council of Ministers was obtained towards AA & ES for increased share of GNCTD. Board considered the proposal and resolved to approve the same, with the conditions that NRW must be reduced less than or equal to 15% within 03 years of construction phase, so work order to be issued accordingly.

RESOLUTION NO.1528

ITEM NO. T-523(On Table):- Improvement of Water Supply System including Operation and Maintenance of Transmission & Distribution Pipes, Pumping Stations, Service Connections and Consumer Meters with DMA formation and NRW Reduction in Chandrawal WTP Command Area, Package – 4 (East).

It was discussed that the Proposal contained in Preamble No. C.E.(W) PR-II/2025/P-12 was earlier placed before the Board in its 172nd meeting vide Resolution no. 1443, Item No. T-467, wherein Board was agreed with the proposal since the project cost escalated the Board recommended that concurrence of Competent Authority for this scale of project be first obtained then it should be put up before the Board. Now, CE(W)Pr-II informed that the approval of Council of Ministers was obtained towards AA & ES for increased share of GNCTD. Board considered the proposal and resolved to approve the same, with the conditions that NRW must be reduced less than or equal to 15% within 03 years of construction phase, so work order to be issued accordingly.

Board further suggested that the progress of appointment of Consultant for Master Plan and optimum utilization of DJB land be apprised to Board in next meeting.
