CONFIRMATION OF MINUTES:

While confirming the minutes, Hon'ble Members drew the attention of the Chairperson towards the followings:

Sh Yog Dhayan Ahuja, Hon'ble Member raised the issue relating to the upgradation/down- gradation of contractors in Delhi Jal Board. He wanted to know the latest position.

C.E.© C-II mentioned that the details in the matter had since been submitted to higher authorities to hold a meeting of the committee shortly. Taking note of the pendency of the matter since long, it was desired by the Hon'ble Chairperson, Delhi Jal Board that the issue be clinched within a month's time.

While deliberating on this issue it was also felt that the exercise should also take into account the performance of the contractors and that opportunity be also given to fresh blood.

Sh. Shadi Ram, Hon'ble Dy. Chairman sought the information regarding Delhi Jal Board's departmental tankers etc. Hon'ble Chairperson, DJB desired that the requisite information be made available to the Hon'ble Dy. Chairman within two days.

While talks were going on, on this issue, Sh. Shadi Ram, Hon'ble Dy. Chairman also suggested that old un-repairable vehicles/tankers be disposed off in the interest of the department.

Sh. Shadi Ram, Hon'ble Dy. Chairman also asked for information pertaining to the issue of appointment on compassionate ground. He was informed that the matter is receiving attention and the process of scrutiny of the concerned cases was on.

Sh. Shadi Ram, Hon'ble Dy. Chairman also referred to a circular issued by the Revenue Deptt. of Delhi Jal Board regarding 'acceptability makes' of water meters. Drawing attention to this he mentioned that some of the companies listed in the circular have since been closed in the market.

Clarifying the position, Director (Revenue), DJB mentioned that the circular in question was being withdrawn and the matter as a whole was receiving the attention for appropriate remedial action.

Intervening in the matter Hon'ble Chairperson desired that DJB should invariably take note of the utility and efficacy of generally old circulars in the context of a dynamic environment and that the review exercise in respect of all such circulars should be a continuous process. Taking pragmatic note of the basic requirement in the matter of water meters the consencus was that a knowledgeable technical sub committee should carefully go into all relevant aspects, before finalising the exercise of procurement.

Sh. Shadi Ram Hon'ble Dy. Chairman had asked for some information regarding Delhi Jal Board land under unauthorized encroachments. The due information was made available to him. In this context Hon'ble Chairperson further desired that in order to protect the DJB land from unauthorized encroachments, proper boundary walls should be raised in all feasible cases.

Sh; Ashok Kumar Tanwar, Hon'ble Member had asked information regarding engagement of drivers deployed on tankers on contract basis. The information was made available to the Hon'ble Member.

RESOLUTION 941: Taking clue from the content of RESOLUTION No 941, Hon'ble Dy. Chairman DJB mentioned that while putting up the proposal of adhoc appointment/promotion etc, ACR's of five years should be taken into account. In this respect it was explained that whenever appointment/promotion cases are brought before the Board, the relevant ACRs of requisite period are invariably seen. However, in cases of adhoc continuation of any promotion from year to year basis, only the preceding year's ACR in question is naturally taken note of.

RESOLUTION 944: While deliberating on RESOLUTION no 944 pertaining to P/L/J 900-700-600-500-350 & 200 mm dia DI/MS peripheral water supply main for built up area in the command of reservoir CT-2(Ph-II) Dwarka, the Board took further view that pipes supplied by M/S. Lanco Const. Ltd. at site must be of ISI specification and inspected by a third party as per terms and conditions of NIT.

RESOLUTION 1002: The Board took another opportunity to have a fresh look at the RESOLUTION No 1002(Item No. 1012). It was felt that the Ex-gratia amount already made available to group B gazetted employees of DJB need not be recovered as a part of goodwill gesture. This mater was deliberated upon at length bringing into focus all relevant aspects in the subject area. The Board was informed that the amount involved will be to the tune of Rs. 28.00 lacs approximately. The Board resolved that recoveries from group B gazetted employees need not be made and that DJB should also go ahead as per existing practice in respect of group C & D employees.

RESOLUTION No. 1008 & 1010: There was considerable discussion on the required follow up action in respect of RESOLUTION No. 1008 (Item No. 1018) about Improvement of Sewage system in Rajouri Garden West Zone and RESOLUTION No. 1010 (Item No. 1020) regarding Providing, Laying and Jointing 300 mm dia water CI water line from 1000mm dia mtr PSC water main at Outer Ring Road to Sultanpuri overhead tank in Sultanpuri RSC. In these two RESOLUTIONs Chief Executive Officer DJB had been asked to give a further look into the matter. This was at the instance of Hon'ble Member, Sh. Yog Dhyan Ahuja. The precise issue was whether the Contractor in question was at all eligible to undertake these works. As part of the background, there was a comprehensive report in the matter from the Member(Finance) Delhi Jal Board following an earlier decision of DJB. The report was dated 1.5.2001. The report had taken into consideration the details of not only these two cases but two other cases as well. The Chief Executive Officer DJB explained that Member(Finance) had already carefully gone through all relevant aspects and it would not be prudent at this stage to deny opportunity to the concerned contactor to go ahead with the works. It was also made clear that the issue of up-gradation/down-gradation of contractors was already under examination and an objective view would be not to hold back these cases any longer. It was also mentioned that in the concerned cases figuring this very contractor there should be third party inspection for quality checking. However, further action should not be deferred. Accordingly, the Board resolved to give a go ahead signal for the Item No. 1018 and 1020.

The Board examined the proposal contained in Dir.(A&P)'s letter No. DJB/125 dt. 03.10.2001 and resolved to allow adhoc promotion to S/Shri G.C. Nandwani, L.N.

Kapoor, V.B. Jain and S.C. Gupta, S.E©s to the post of Chief Engineer (Civil) in the pay scale of Rs. 18400-22400 with immediate effect, for a period of one year in the first instance or till such time the posts are filled in on regular basis through U.P.S.C., whichever is earlier. The Board deliberated on this issue at length and resolved that progressive personnel policies need to be followed. Shri Shadi Ram Hon'ble Dy. Chairman desired to know about regularization of persons engaged after 31.12.1992. It was informed that Muster Roll employees are regularized in a phased manner.

However, while deliberating on this item and specifically on another item, the Board unanimously felt that in the interest of quality construction, both civil and Electrical and Mechanical works be subjected to thorough inspection. Keeping in view this need the Board resolved that all civil works costing more than Rs. 1 crore should be inspected through a third party. The agency empowered to undertake such inspection, should be of considerable repute such as Engineers India Ltd., RITES etc.

It was also decided that Electrical & Mechanical works should also be subjected to third party inspection. Cases involving procurement of substantial equipment and material such as Alum/Chlorine should also be subjected to third party inspection.

It was also felt that whenever the awarded rate is found to be below 25% of the departmental justification, third party inspection of the awarded work should be undertaken..

The progress should undergo rigorous monitoring and a close eye on how things are implemented by the other side.
