# **CONFIRMATION OF MINUTES:**

The Minutes of the 44<sup>th</sup> meeting of the Delhi Jal Board held on 19.10.2001 & 20.10.200120.10.2001 were placed before the Board for confirmation. Shri Yog Dhayan Ahuja, Member once again insisted regarding RESOLUTION No. 1008 & 1010. Member(Finance) drew the attention of Hon'ble Member and the Board towards his report dated 1.5.2001 already placed before the Board alongwith Item No. 1020. He read out relevant portion of the report the brief of which is as under:-

"M/s Vijender Kumar & Co. is a registered contractor in category-II, tendering limit upto Rs. 1 crore in D.J.B. He has intimated to the department about change in constitution from partnership concern to propriety concern in October-1997. His request has been examined in detail in consultation with legal cell and intimated under the signature of E.O.

to C.E.©-II dated-14.04.1999 that there is no objection to the department with regard to change in constitution from partnership to proprietary concern."

With the above clarifications given by the Member(Finance) the minutes of the 44<sup>th</sup> meeting of the Delhi Jal Board were confirmed with the dissent note of Shri Yog Dhayan Ahuja on Resolution No. 1008 & 1010.

While confirming the minutes, Hon'ble Members drew the attention of the Chairperson towards the following:-

- 1. Shri Shadi Ram, Hon'ble Vice-Chairman desired that seniority list of cases pending for appointment on compassionate ground be prepared and deserving cases may be given priority.
- 2. He pointed out that the circular regarding promotion and transfer/posting of senior officers are not being sent to his office regularly. Chairperson directed that all circulars regarding transfer/posting and promotions etc. of senior officers should be sent to Vice-Chairman office.
- 3. Vice-Chairman desired that in all cases regarding promotion/Appointment of senior officers, in the preamble department should certify that ACRs of requisite period as per Recruitment Rules have been seen and clearance of vigilance has been taken.
- 4. Shri Shadi Ram, Vice-Chairman retreated that all circulars more than three years old be updated.
- 5. Shri Shadi Ram, Vice-Chairman pointed out that supply of water throuth tankers is very expensive. Efforts should be made for piped/skeleton water supply in the entire N.C.T. of Delhi wherever possible. Chairperson has suggested that a comprehensive survey can give the complete picture and directed that C.E.©-I will give a report on the issue in the next meeting. He pointed out that a number of tankers are lying stand still inoperative for want of repairs or supply of tyres etc. C.E.©-I informed that at present 550 tankers are on road out of 597. 47 are being repaired and can be on road within next month.
- 6. Shri Yog Dhyan Ahuaja, Hon'ble Member raised the issue of Lokayukta Report. The Chairperson directed that CEO should distribute the copy of the report to all members.
- 7. Shri Ashok Tanwar, Hon'ble Member pointed out that some time due to non-extension of validity of rate the department has to go for retendering and causing heavy loss of revenue due to higher rate received in retendering.
- 8. The matter regarding award of work other than lowest tenderer was discussed in the meeting in detail. However it will not be possible in view of the latest guidelines issued by the Central Vigilance Commission.

- 9. Shri Ashok Tanwar, member desired that a report on replacement of water lines in Karol Bagh Zone may be made available to him. C.E.©-I has been directed to submit the report.
- 10. Shri Shadi Ram, Vice-Chairman desired progress in case of construction of open carrier lined channel from Munak to Haiderpur water treatment plant and appointment of Co-ordinator or Sub-Committee to watch progress and rigorous monitoring.

# **RESOLUTION NO. 1147**

ITEM NO. 1165 Disciplinary proceeding against Shri Mahender Singh, Executive Engineer (E&M).

The Board considered the proposal contained in Addl. C.E.O's letter No. DJB/04 dated 20.12.2001, second stage advise of Central Vigilance Commission and reply submitted by Sh. Mahender Singh, E.E. (E&M). In the charge sheet the main charge was that Sh. Mahender Singh, while working as Executive Engineer (E&M) during the year 1983-84, committed the acts of omission and commission and issued two recommendatory letters as head of SC/ST Employees Welfare Association in favour os Sh. Uttam Kumar. He failed to disclose his relationship with Sh. Uttam Kumar. Further he was one of the members of the Selection Committee who selected Sh. Uttam Kumar. On the basis of the recommendations of the Selection Committee, Sh. Uttam Kumar was given regular appointment to the post of AE(E&M). Later Sh. Uttam Kumar was posted under the control and supervision of Sh. Mahender Singh, EE(E&M) and even then Sh. Mahender Singh did not inform the department about his relationship with Sh. Uttam Kumar.

Smt. Divjot Kohli, IRS, appointed as Inquiry Officer in the year 1994, submitted her report on 27.1.2000 and on the basis of record and evidences of department as well as defence she concluded that charges leveled against the Charged Official are 'NOT PROVED'. The Delhi Jal Board in the capacity of Disciplinary Authority didn't agree with the Inquiry Report and directed the department of refer the case of C.V.C. for second stage advice. C.V.C vide its letter date 2.11.2000 stated that the commission was in disagreement with the IO. C.V.C. held the charges against the C.O as proved and advised imposition of a suitable major penalty on Sh. Mahender Singh, E.E.

Sh. Shadi Ram, Acting Chairman, while deliberating on the issue observed that Sh. Mahender Singh, EE(E&M) was the junior most member of the Selection Committee, which made selection of Sh. Uttam Kumar. Therefore, it can't be said that selection of Sh. Uttam Kumar not on merit.

After thorough discussion and considering the Charge sheet, Inquiry report, reply of Charged Official and advice of the C.V.C., the Board unanimously decided that the penalty of CENSURE upon the C.O. would meet the end of justice. The Board, therefore, resolved to impose penalty of 'CENSURE' upon Sh. Mahender Singh, Executive Engineer (E&M).

The Board further resolved that this preamble and the annexure be classified a secret document, the copies of which shall not be made available to anyone even on payment of any fee, unless expressly ruled otherwise by the C.E.O.
