The Board after careful consideration of the proposal and suggestions of the Vice-Chairman and Member of the Board, further resolved for purchase of PAC as under:

- 1. 500 M.T. of P.A.C Arya from M/s Grasim Industries @ Rs. 5000/- per M.T. with assured and guaranteed consumption of 40% vis-à-vis Alum and 4000 MTs of PAC-AC-100/S with assured and guaranteed consumption of 50% vis-à-vis Alum @ 4375/- per M T; and
- 2. 4000 MTs of PAC-Ecorite-2010 of high basicity from M/s Shri Ram Vinyle & Chemical Industries @ 5460/- PMT with assured and guaranteed consumption of 40%, vis-à-vis Alum.
