Shri Kanwar Karan Singh, Member mentioned that the contractor in question i.e M/s Offshore Pvt. Ltd., who was allowed to use DJB land for executing the Board work, was perhaps misutilizing the land for executing the work of agency other than Delhi JaL Board. Chief Engineer concerned explained the matter and he was directed to look into the matter and submit facts.

same rates, terms and conditions of the original CA No. 1 (2002-03)/EE©DR XV and subsequent negotiation in the Technical Committee. The Board further resolved to take action in anticipation of confirmation of minutes.
