ORDER

This order will dispose off an appeal received on 7.4.2015 (ID No. 270) filed by Shri J.L. Nehru, under Section 19(1) of RTI Act-2005.

The matter was taken up for hearing on 21.04.2015. Present Vinay Nehru for appellant and Shri D.K.Saxena, APIO/ZRO (NW)-II on behalf PIO. After perusal of the RTI application and the appeal filed by the appellant it is noticed that the appellant has asked for the statement of the relevant bills indicating OMR, amount billed, payment received/ outstanding in respect of the bill period from December 2010 to February, 2011. The appellant has also alleged that the RTI application was returned twice on some pretext or other from the APIO's office. The APIO is directed to sensitized his subordinates to not to return the RTI applications on flimsy grounds and accept all types of payments as prescribed in RTI Act. The RTI application is vague about asking specific information which is basically a grievance of raising bill on a locked premise on average basis. APIO, who is ZRO of the area, is directed to look into the grievance and provide solution to the consumer -appellant as per rules and regulations of DJB within 15 days of passing of this order.

In the light of above the appeal is accordingly disposed off.
