ORDER

This order will dispose off an appeal received on 22.04.2015 (ID No. 1950) filed by Shri Raj Kumar Sharma under Section 19(1) of RTI Act-2005.

The matter was taken up for hearing on 27.05.2015. None present for the appellant and Shri Shiv Prasad APIO/ZRO (E)-I was present on behalf of PIO. As per RTI application dated 17.03.2015, reply has been given by the PIO on 17.04.2015. As per reply, since the information is not available in the office, APIO/PIO could not provide information to the applicant. As per record submitted by the APIO/ZRO of the area, there was fire incidence in 2007 for which an FIR was also filed vide No.336 dated 11.05.2007 in Police Station Preet Vihar and there is a likelihood that all the concerned files got destroyed in the same fire. It is also observed that the information asked pertains to water connection in the name of Sh.B.B.Lal where as the applicant name is Sh.Raj Kumar Sharma. Therefore, the said application may fall under the Section pertaining to third party information under RTI Act 2005. In the light of above, PIO is directed to once again try to locate information as required by the applicant and if found, the reply be given to the applicant within 15 days of passing this order after fulfilling all obligations including section pertaining to third party under the RTI Act-2005.

In the light of above the appeal is accordingly disposed off.

In case, the appellant is not satisfied with the orders of First Appellate Authority / information provided to her by the PIO after passing order by the FAA, he may approach the CIC for getting the information as required by him at the address mentioned below :-
