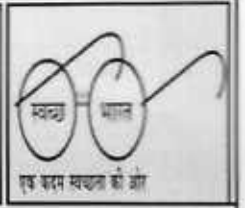

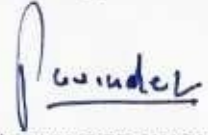

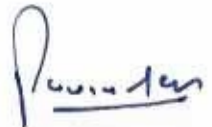

TERMS AND CONDITIONS FOR ENGAGEMENT TO THE POST OF JUNIOR ENGINEER (CIVIL) ON CONTRACT BASIS IN DELHI JAL BOARD.

1. The appointment to the post of Junior Engineer (Civil) shall be purely on Short-Term Contract basis. He/she shall report to the undersigned by 20.05.2025 between 10 a.m. to 05 p.m. failing which his/her candidature will be cancelled.
2. Persons appointed to the post of Junior Engineer (Civil) on Short-Term Contract shall undergo medical examination and their character & past antecedents will be verified from Police Authorities by DDO concerned.
3. The appointment of Junior Engineers (Civil) shall be on Short-Term Contract for a period of one year from the date of appointment or when the vacancy filled by the DSSSB, whichever is earlier. Further, the engagement may be extended time to time on yearly basis as per the requirement of the Department.
4. The selected candidates will be paid a consolidated remuneration on the basis of entry stage of Pay Matrix Level 6 at the entry stage + DA. No other allowances or facilities, available to regular employees, shall be payable to person appointed on Short-Term Contract.
5. In case of delayed payment of remuneration, no interest will be paid.
6. The department will not bear any kind of liability/responsibility during the period he/she remains on contract with Delhi Jal board except payment of contractual remuneration for his/her service rendered to the department.
7. DJB will not be responsible for any incident/accident of the contractual employees during the period of deployment in Delhi Jal Board.
8. If any contractual appointee Junior Engineer (Civil) remains absent from duty for more than one week continuously without any intimation, his/her contractual engagement will automatically stand discontinued.
9. In case of fresh engagement/re-engagement or extension of the period of contract, the department shall again enter into a fresh contract agreement.



10. Only one day C.L in a month will be admissible to the contractual employees, which shall not be carried forward to next calendar year.
11. In case Contractual appointee is found indulging in malpractices or involved in criminal offences or commits act of indiscipline or involved in mis-utilization or embezzlement of funds or failed to perform the duties assigned to him by his seniors, or his conduct/work is not satisfactory, his contractual engagement may be terminated immediately without any prior notice and legal action as deemed-fit may be taken against him/her.
12. He shall render professional, objective and impartial services and at all times uphold the employer's interest. He shall avoid conflicts with other assignments and his own interests. He will maintain absolute punctuality, discipline and decorum during the period of his engagement. He will maintain ethical behaviour and integrity beyond doubt.
13. He shall not divulge or make unauthorized use of any confidential information which includes correspondence, documents of the DJB acquired during the period of this agreement.
