- (b) On expiry of the aforesaid scheme of reduced rate of development charges, if a consumer is unable to pay the development charges as per the notified rates in lump sum or in part, then in that case simple interest @ 10% per annum will be levied on expiry of 12 months period from the date of notification of service in a colony.

The plot-holders / occupiers are advised to apply for sanction of water connection in the prescribed form which may be obtained from the office of Zonal Revenue Officer(NW)-II, Safiabad Road Over Head Tank, Narela, Delhi-110040.
