## **PUBLIC NOTICE**

To encourage water conservation, Delhi Jal Board have following policies to increase use of treated effluent (Grey Water) for Non-potable purposes i.e. Irrigiation, Agriculture, Cooling Plants, Construction Industries, Flushing and Washing: -

- a) DJB has approved the policy for implementation of Decentralized waste water treatment plant system for institutions/Schools/Colleged etc. for utilization of treated waste water for Horticulture to reduce extraction of ground water. The waste water will be suitably treated as per DPCC/CPCB/CPHEEO norms for utilization for non potable usages, largely for horticulture. To encourage the implementation of installation of decentralized STPs, only 10 % of the sewerage mantenance charges on the volumetric consumption of water will be lieved instead of the 60 % of volumetric consumption charges wherevew applicable.
- b) DJB has facilitated utilization of treated effluent through tankers for which filling points are provided at all major STPs for filling tankers for non-drinking purpose requirement of various agencies at a cost of Rs. 7 per KL.
- c) Bulk consumers like DDA, MCD, PWD, Railways, DMRC or Private agencies may create their own infrastructure alongwith pumping arrangement for use of treated effluent which will be charged @Rs. 4 per KL.
- d) Following are guidelines for use of treated effluent through tankers
- 1. The rates of treated effluent shall be charged @ Rs.7.00 per Kl.
- 2. The tanker/containers shall be arranged by the beneficiaries.
- 3. The container/Tankers shall be **painted with yellow colour** duly marked with (the precaution) in **Red Colour** "Water is not fit for drinking purposes".
- 4. In case of any difficulty or problem the respective plant In-charge may be contacted in this matter.
- 5. The treated effluent shall be available at the filling points at following Sewage Treatment Plants in different Zones.
- e) Mode of payments: -
- i) ATM machines at bigger Sewage Treatment Plant by Corporation Bank or any other Bank.
- ii) Online payments through RMS
- iii) G-8 from various Zonal Revenue Offices or Divisional Offices.
- iv) At Filling Points itself through G-8 or ATM whichever available
- f) The quality of the treated effluent (Grey Water), list of filling station alongwith contact no. or engineer in-charge is as below: -

g) Role and responsibilities of consumers- As per notification issued by Hon'ble LG Delhi vide notification dated 18.05.2010 under section 5, Environment Protection Act 1986, on the regulation and management of groundwater which mandates the use of recycling water both at the time of granting permission for new borewells as well as for continued use of existing borewell. Hon'ble NGT has stressed upon the need to use treated effluent/waste water instead of extracting ground water and directed every Govt. Departments/private in public agencies for bulk requirement for parks, gardens, washing and cooling.
