In pursuance of the provision of section 32 of the Delhi Water Board Act, 1998, it is notified for general information of the public that in the Territorial area of Delhi specified in the schedules given below, the internal sewerage system has been completed and made functional for collection, removal and disposal of all the filth, polluted and obnoxious matter from latrines, urinals and cesspools. It does not include any industrial effluent or any other discharges prohibited under law.

It is notified, that development charges for sewage @ Rs.100/- Per Sq.m. of the plotted area are recoverable with 12% simple interest till date of payment by the applicant being covered under the old scheme. The residents who had deposited the whole amount of sewer development charge prior to 30-09-2000 are not required to pay any sewer development charge under this notification. However, such plot holders who had not paid any amount or had paid only advance amount, are required to pay the difference. Interest at a rate of 12 % per annum will be levied till the payment is made taking base year as 30.09.2000. The list of such residents is on record, hence Z.R.O concerned will issue demand letters to remaining 144 plot holders within 3 months.

If a plot-holder of a colony does not deposit sewerage developments charge his/her water connection will also be dis-connected after serving him/her notice of demand.

The plot-holders / occupiers are advised to apply for sanction of sewer connection in the prescribed form which may be obtained from the office of Zonal Engineer-III (North East-I), 2142 Janta Flat, Nand Nagri, Delhi. The form can also be down-loaded from DJB's website www.delhijalboard.nic.in. After sanction of sewer connection and payment of initial charges, sewer development charges and road restoration charges, the applicant shall be allowed to obtain connection and executing the work at his level by engaging a licensed plumber. The onus will be on the plot-holders to get the bills from above office of D.J.B for development charges.
