It is notified, that development charges for water @ **Rs.440/- per sq. m** of the plotted area are recoverable as per formulae given here under:-

- (a) A property owner, as per erstwhile practice will get rebate of 20% on the total due amount, if the same is deposited in lump-sum within 3 months from the date of notification.
- (b) After expiry of 3 months, the rebate will be reduced to 10%, if the outstanding amount id paid in lump-sum within next 3 months. In case of payment in instalments no such rebate will be given instead interest @ 12% p.a. will be levied from the date of notification.
