PUBLIC NOTICE

Notice is hereby given in pursuance of section 9 (1) (a) of the Delhi Water Board Act, 1998 that in the area of state of Delhi as specified in the Schedule below, water is available from the water source of the Board for reasonable supply to all the lands and buildings in such area.

It is notified, that development charges for water @440.00 Per Sq.m. of the plotted area are recoverable, subject to following conditions:

- (a) Water development charge would be recoverable at the rate Rs.100/- per sq. mtr. for properties used for residential purposes having area upto and including 200 Sq. Mtr. upto three months from the issuance of this Public Notice, as the colony is eligible as per notification No.DJB/DOR/D.D.(R)HQ-II/ 2016/1201 to 1325 dated 02-02-2016/ No.DJB/DOR/DD(R)HQ-II/2015/7379 to 7567 dated 29-06-2015.
- (b) On expiry of the aforesaid scheme of reduced rate of development charges, if a consumer is unable to pay the development charges as per the notified rates in lump sum or in part, then in that case simple interest @ 10% per annum will be levied on expiry of 12 months period from the date of notification of service in a colony.

The plot-holders / occupiers are advised to apply for sanction of water connection in the prescribed form which may be obtained from the office of Customer Service Centre of Delhi Jal Board – M/s. NWS Pvt. Ltd. at Uttam Nagar Najafgarh Road Near Nangli Mor, Rana Ji Enclave, Najafgarh, New Delhi-110043 & you may contact to Toll Free No.1800-30000-136. The form can also be down-loaded from DJB's website www.delhijalboard.nic.in. After sanction of water connection, payment of initial charges, including water development charges, road restoration charges and water connection installation charges, M/s. NWS Pvt. Ltd. will install the water connection from DJB water line to the boundary of applicant's property. The onus will be of the plot-holders to get the bills from above office of D.J.B. for all charges to be paid for taking new water connection.
