PUBLIC NOTICE

Application are invited from eligible persons who possess the following qualification/eligibility for registration of new plumbers in Delhi Jal Board. After obtaining a plumber license from Delhi Jal Board, the individual shall be recognized as an Authorized Plumber. He will be eligible to undertake plumbing works related water supply and sewerage systems of Delhi State. Such authorization shall enable him to operate under the technical standards prescribed by DJB. However, the licensed plumber will not be a Government servant and he shall not be necessarily associated with any project work of DJB, and shall work purely on private basis as a self-employed professional.

The proposed eligibility criteria for applicants are as follows:

- i. He/ She is a citizen of India & at-least 18 years of age, and
- ii. (Holds one of the following qualifications)
 - a) A diploma in Civil Engineering or an equivalent or higher qualification as approved by AICTE.
 - Or
 - b) 10th pass from recognized Education Board with at least one year of experience in plumbing works, duly certified by a Government/Private Construction Agency, or Registered Contractor in any Government organization.
 - Or
 - c) Holds a pass certificate in Plumbing or Sanitation from a recognized Industrial Training Institute or a certificate of Skill Development Programs of any States or UT or Central Govt. like Pradhan Mantri Kaushal Vikas Yojna Skill development mission etc.
 - Or
 - d) Registered plumber in any Government department/agency.

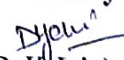
OTHER TERMS & CONDITIONS:

1. Mere applying for the Empanelment/registration for Licensed Plumber does not make any right for issue of license for plumber.
2. Only individual candidates may apply. No. firms/partnerships/company shall be eligible.
3. Candidate meeting the eligibility criteria will only be eligible for registration in Delhi Jal Board.
4. Delhi Jal Board may grant license to any person in accordance with the provisions and may charge fee for the same at such rates as may be fixed from time to time by the Department.
5. Every license granted shall be valid for a period of 05 years up to 31st day of March applicable following the date of issue and as amended from time to time.
6. Eligible candidate shall be required to deposit Rs. 5000/- as security Deposit in the form of FD and License fee of Rs. 2000/- for five years. In addition registration fee of Rs. 150/- and Plumbing License Booklet charges of Rs. 25/- subject to revision/prevaling charges, will be applicable at the time of registration. A fee of Rs. 100/- for issue of Laminated Identity Card will be applicable and as amended from time to time.
7. All the photocopies of documents attached with the application must be Self Attested and both the pages of the application must be signed by the applicant.
8. Decision of the Competent Authority of Delhi Jal Board shall be final in the matter/ant dispute.
9. Applications received through DAK/Speed Post and after due date shall not be entertained and deemed to be rejected.
10. Procedure for Registration of Plumbers: After the invitation of applications, all submissions shall undergo screening and preliminary assessment by Delhi Jal Board. The shortlisted candidates will be required to undergo training at designated training centers approved by DJB. The training fee of Rs. 2500/- shall be borne by the applicants themselves. Upon successful completion of the training, the candidates shall be required to appear in an examination conducted by the authorized Training Center Only those candidates who successfully qualify the examination shall be granted a Plumber's License by the Delhi Jal Board.

Two hundred only) in favour of Delhi Jal Board and three (03) recent identical colour passport size photographs.

Last date of submission of application is 14 November, 2025.

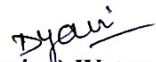
