It is notified, that development charges for water @ Rs. 440.00 Per Sq.m. of the plotted area are recoverable, subject to following terms & conditions:

The plot-holders / occupiers are advised to apply for sanction of water connection in the prescribed form which may be obtained from the office of **Zonal Revenue Officer (North)-II, Majlis Park, Kewal Park, Delhi-110033.** The form can also be down-loaded from DJB's website www.delhijalboard.nic.in. After sanction of water connection and payment of initial charges, water development charges and road restoration charges, the applicant shall be allowed to obtain boring permission and executing the work at his level by engaging a licensed plumber. The onus will be on the plot-holders to get the bills from above office of D.J.B. for development charges to be paid.
