PUBLIC NOTICE

Notice is hereby given in pursuance of section 9 (1) (a) of the Delhi Water Board Act, 1998 that in the area of state of Delhi as specified in the Schedule below, water is available from the water source of the Board for reasonable supply to all the lands and buildings in such area.

The plot-holders/ occupiers are advised to apply for sanction of water connection online through DJB customer portal www.djb.gov.in.

In accordance with the category of colonies for property tax, connection installation charges as per the prevailing DJB policy Rs. 1000 for domestic 15mm connection and Rs. 2000 for commercial 15mm connection will be payable. The sewer connection will be approved automatically with the approval of the water connection.. No separate sewer charges will be levied. After payment of connection charges, the connection will be laid by DJB including the installation of the water meter. Infrastructure charges are payable on properties/ units on plot size above 200 sqm. as per applicable norms.
