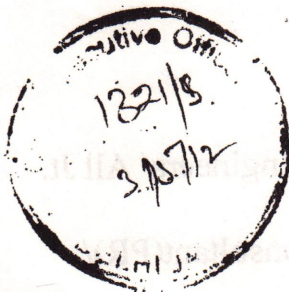
This has reference to Home Secretary, Govt. of India, Ministry of Home Affairs D.O. No. T-203/HS/2012 informing thereby that specific instances have come to the notice of the Ministry where officers have been in touch with/interacting with Foreign Service Nationals (FSNs)/Embassy officers/staffers of other countries in contravention of the laid down rules and circulars. Such contacts give an opportunity to Foreign Service Nationals and Embassy officers/staffers (some of whom may be Intelligence Operatives) to cultivate sources within the Government and/or push their agenda. Government have also come across specific instances where officers at different levels have been in touch with Foreign Service Nationals/Embassy officers/staffers for personal favours e.g. being nominated for courses abroad, etc. This is entirely reprehensible. Further it has been requested to advise all officers to strictly follow the extant rules and guidelines laid down vide No. 15/13/69-Disc. dated 24th January, 1970 MHA O.M. No. 25/34(5)/67-Ests.(A) dated 22nd May, 1969.

This is for information and strict compliance.

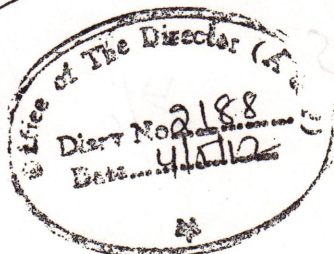
