DGW/CON/204 dated 02-11-2004 have introduced clause 10 CA for making payment of escalation in respect of cement and steel reinforcement bars for their work where stipulated period is 18 months or less. Delhi Jal Board have also introduced the said clause in DJB Contracts but there had been demand from Delhi Jal Board Contractors Welfare Association for including M.S pipes & specials, Cast Iron pipes & specials and Ductile Iron pipes & specials in Clause 10CA for making payment of escalation for such material. The demand of Delhi Jal Board Contractor Welfare Association has been examined carefully and it was decided to include the above material under Clause 10 CA for regulating payment of escalation because these materials form the major component of works of water lines being executed by Delhi Jal Board. Clause 10 CA has been reframed and is circulated for its incorporation in the tenders to be invited hence forth.
