
**CIRCULAR**

**Sub:- DVAT-TDS Changed from 2% to 4% w.e.f. 16.01.2013**

DVAT TDS has been increased to 4% vide Govt. of NCT of Delhi Finance (Revenue)-I endorsement No F 3(9)/Fin(Rev.-I) / 2012-13/ cls-VI-34-39 (copy enclosed).

Therefore, henceforth DVAT TDS should be deducted @ 4%.

In cases, where DVAT-TDS has already been deducted @2% on or after 16.01.2013, the balance should be deducted and remitted into Bank immediately.


