INSTRUCTIONAL ORDER

Delhi Jal Board has 112 Suction-cum-Jetting machines and 8 Recyclers for maintenance of sewer lines. It has been observed that proper utilization of the available resources is not being done. These machines are doing emergency response instead of preventive maintenance. To improve the drainage system and ensure optimum utilization of available resources, the following instructions are circulated for strict compliance by the concerned officers.

- The advance monthly deployment schedule of Recycler and Suction-cum-Jetting machines will be prepared and submitted by the concerned EE to their SE/CE and Member (Dr.). The Residents Welfare Associations will be informed in advance before deployment of machines. CE-wise deployment schedule shall also be uploaded on DJB website.
- Recycler shall be used only for desilting of sewer lines and Suction-cum- Jetting machines for blockage removal. Recycler shall be engaged as per schedule and shall not be diverted till completion of desilting/ cleaning.
 - . Monthly report of deployment of these machines will be sent to the office of CE and Member (Dr.) without fail latest by 5th day of subsequent month.
- 4. Desilting of peripheral sewer lines shall be started from downstream i.e. confluence point of peripheral sewer and trunk sewer and move backward up to the tail end to ensure maximum benefit of desilting work. Similarly, while doing desilting of peripheral sewer lines, its lateral should also be cleaned by Suction-cum-Jetting machine simultaneously for best results.
- 5. The agency deploying recycler/suction/super sucker machine will take real time photographs/ videographs and forward the same to concerned EE through email or any other media. Daily Log-sheet shall be signed by the supervisory staff not less than the rank of SI/JE and copy of the Log-sheet duly verified by the

supervisory staff shall be e-mailed or subsequently sent manually to concerned EE on daily basis.

- Any estimate for engagement of additional super sucker machines, desilting of sewer lines or replacement of sewer line due to heavily silting up shall be seen by CE concerned irrespective of any amount.
- 7. In case of engagement of S.G. Beldar through contractor, the concerned Division should ensure that the contractor is not violating the rule of payment of minimum wage Act and the payment to the engaged Beldars are made in presence of JE concerned.
- The payment of hired recyclers and Suction-cum-Jetting machines shall be made only after compliance of above instructions and bills are supported with log sheet duly signed by JE and RWAs and photographs/ videographs with date.
