**Circular**

In partial modification in enlistment rules of contractors, the following has been approved by the Competant Authority i.e. CEO (DJB).

As per existing clause No. 17.0 of Rules of Enlistment of Contractor in DJB followed in Delhi Jal Board, " Contractors whose near relatives are Divisional Accountant or Engineering Officers between the grades of Chief Engineer and Junior Engineer (both inclusive) in the Delhi Jal Board will not be allowed to tender for works in the circle responsible for award and execution of contract is the one where the near relative is working. For this purpose a near relative shall mean wife, husband, parents, grandparents, children, grandchildren, brothers, sisters, uncles, aunts, cousins and their corresponding in-laws."

**Clause 17.0 have been modified and read as below with immediate effect:-**

**Clause 17.1 Restrictions for close relatives:** CEO, All Members, All Directors, Jt. Directors, Secretary (DJB), All Assistant Commissioners, Dy. Directors, CWAs, ACWAs, Entire engineering cadre from JE to CE (both inclusive) and Entire Finance Cadre from Divisional Accountant and above, themselves and their close family members **will not be allowed to be enlisted as DJB contractor in any class and will not be allowed to participate in the tenders of Delhi Jal Board during their tenure of service in DJB.** For this purpose, definition of 'Close family member' shall include respective spouses, parents, children and children's spouses. X.

**Clause 17.2. Restriction for near relatives:** In addition to above contractors whose near relatives are in the finance cadre in the rank of Divisional Accountant and above or Engineering Officers between the grades of Junior Engineer and Chief Engineer (both inclusive) in the Delhi Jal Board will not be allowed to tender for works in the circle responsible for award and execution of contract is the one where the near relative is working or supervising. For this purpose near relatives shall include grandparents, grandchildren, brothers, sisters, uncles, aunts, cousins and their spouses and corresponding in-laws. For the sake of clarity, it is reiterated that close relatives (respective spouses, parents, children and children's spouses and the individual himself/herself).
