Subject: - Payment of water /sewer bills through NEFT/RTGS- reg.

In order to facilitate the consumers, DJB has introduced payment of water /sewer bills through NEFT/RTGS in addition to existing arrangements. For the purpose, ICICI and Kotak Mahindra Bank have been authorized. Now, consumers have an additional option to pay their water /sewer charges bills through NEFT/RTGS of ICICI or Kotak Mahindra Bank. For the purpose, necessary integration has been made with the Revenue Management System of Delhi Jal Board.


