Subject: Notification regarding material for installation of all new House Service Connection in Delhi.

A Study Group comprising S.Es/E.Es of D.J.B. was formed for suggesting measures for reduction of Non-Revenue Water (NRW) by replacement of House Service Connections. Study Group suggested mandatory use of improved material for House Service Connections while installing new water connections. The recommendations of the Study Group have been accepted by the competent authority. Accordingly, House Service Connection pipe arrangement from ferrule to meters will be as under:-

- 1. Tapping with Saddle (DI or MDPE composite) the bore size to be maintained as 8 mm or as sanctioned with additional control through adopter of same (bore) size fitted in the saddle.
- 2 MDPE pipe for underground portion, conforming to minimum PE80 grade ISO specifications (ISO 4427 and BS 6730-1986) for carrying potable water.
- 3. Gl pipe of class 'B' conforming to relevant IS code for above ground portion up to water meter.

This requirement is also being included in the new water connection forms for the information of the

applicants.
