Subject: Penalty on account of non compliance of Rain Water Harvesting provision.

As per provisions of Delhi Water & Sewer (Tariff and Metering) Regulation 2012, Rain Water Harvesting is mandatory for property/floor size of 500 Sq.mtr. or more. This provision was to be made functional by the commercial/industrial category consumers of the Board within one year and by the domestic consumers within 3 years from the date of coming into force of above regulations i.e. 31-08-2012. As per tariff regulations, such consumers who fail to comply with the above provision will be charged 1.5 times the normal tariff. Accordingly, vide circular dated 08-07-2015, the above provision was invoked.

2. Subsequent to the imposition of the enhanced tariff, representations from various forums/consumers/associations have been received against imposing aforesaid penalty citing various reasons and therefore, the matter was reviewed when various difficulties in implementing / installing the Rain Water Harvesting System including absence of identified agency who can guide consumers to install Rain Water Harvesting Structure, delay in permission for boring etc. were indicated.

3. Considering the difficulties faced by the consumers, Board has approved to defer the implementation of Rain Water Harvesting penalty till onset of the monsoon season i.e. upto 30-06-2016 and the bill issued to such consumers should be revised as per normal tariff and amount levied/paid by a consumer on this account should be adjusted in the next bill. The consumers would also be advised through a Public Notice to install the system by 30-06-2016 under intimation to the Z.R.O. concerned.

4. The above decision of the Board is being issued in anticipation of the confirmation of the minutes of the meeting by the Board.
