As the level of ammonia pollutant in river Yamuna at Wazirabad Pond is high and on increasing trend today i.e. on 12.01.2021, water production has been curtailed from Water Treatment Plants at Wazirabad, Chandrawal and Okhla and water supply shall be affected in the Morning of 13.01.2021 and in the Evening of 13.01.2021 in the following areas and so on till the ammonia level in river reduces to treatable limit.

The areas likely to be affected are Civil lines, Hindu Rao Hospital and adjoining areas, Kamla Nagar, Shakti Nagar and adjoining areas, Karol Bagh, Pahar Ganj and NDMC areas, Old & New Rajinder Nagar, Patel Nagar (East & West), Baljeet Nagar, Prem Nagar, Inderpuri and adjoining areas, Kalkaji, Govindpuri, Tugalkabad, Sangam Vihar, Ambedkar Nagar. Prahladpur and adjoining area, Ramleela Ground, Delhi gate, Subhash Park., Model Town, Gulabi Bagh, Punjabi Bagh, Jahangirpuri, Moolchand, South Extn., Greater kailash, Burari and adjoining areas, Parts of Cantonment areas and South Delhi.

Therefore, public is advised to make judicious use of water and water tankers shall be available on demand from following water emergencies:
