Subject: Abolition of Rain Water Harvesting Penalty levied on the consumers of Dwarka Sub-city.

Delhi Jal Board had decided to levy Rain Water Harvesting Penalty on its consumers w.e.f. 01-07-2017. Consumers of the Board residing in Dwarka Sub-city had represented that they had not been given sufficient time for installation of functional Rain Water Harvesting System as the services of this sub-city were taken over by the Board from DDA w.e.f. 01-04-2015 and due to time taken in transferring of consumer data etc., billing by DJB was delayed. Further, these consumers have agreed to install functional Rain Water Harvesting System by 30th June, 2018.

- 2. Board duly considered the issue vide Resolution No.525 dated 01-02-2018 and has approved to withdraw the Rain Water Harvesting Penalty imposed on consumers of Dwarka Sub-city w.e.f. 01-07-2017 and further ecided not to levy this penalty upto 30-06-2018 on its consumers of Dwarka Sub-city only with the condition that they will ensure installation of functional Rain Water Harvesting System till then.
- 3. Board had further resolved that payment made by any consumer towards Rain Water Harvesting penalty since 01-07-2017 will be adjusted in future bills except in cases where the consumer is covered under 20 KL scheme in last three consecutive billing cycles, in which case it will be refunded.
- 4. Further, it has also been approved that Certificate about functionality must be deposited/ submitted by the consumer to concerned Z.R.O. by 31st May of every year so that Z.R.O. may forward the same to the concerned Executive Engineer for site inspection and verification, about adequacy and functionality of installed rain water harvesting system. Detailed guidelines defining the procedure to be followed, will be issued separately through administrative order.
- 5. This is for information and necessary action by all concerned.
- 6. This issues with the approval of the Competent Authority.
