## INSTRUCTIONAL ORDER

## Subject: Infrastructure Charges for a premises having multiple dwelling units.

As per existing practice, Infrastructure Charges for Water / Sewer is payable for the properties on plot size more than 200 Sq. Mtrs. Process to be followed and calculations of Infrastructure Charges has been circulated vide CEO's Circular No.CEO/DJB/2017/13731 to 13744 dated 23-03-2017 (copy enclosed). Further, DJB vide Resolution No.455 dated 29-09-2017 has approved to abolish the limit of 10 water connections in a property/ premises which has also been circulated vide Instructional Order No.DJB/CE(Water)Project/2017/273 dated 06-12-2017 and Clarification thereon vide No.DJB/CE(Plg.)W/2018/45 dated 15-02-2018 (copy enclosed).

References are being received in this office that the consumers are normally being asked to pay Infrastructure Charges for the whole property/all Dwelling Units, whereas the consumer owns only one dwelling unit and has applied for water and/or sewer connection for the said unit and is willing to pay his/her share of applicable infrastructure charges for the said dwelling unit owned by him. The matter has been examined and it is clarified that:

"If there are multiple dwelling units in a premises, the consumer who applies for a new water and/or sewer connection for the dwelling unit, as per policy of the Board, the Infrastructure Charges will be payable by the consumer/applicant only for the dwelling unit pertaining to him/he or for which new connection has been applied for".
