CIRCULAR

Subject: Pilot Scheme for sanctioning/regularization of New Water Connection on fixed down payment and balance due in instalments in PPP1 areas of M/s. Malviya Nagar Water Services Pvt. Ltd. (MNWS) only.

A large number of unauthorized water connections exist in various parts of Delhi and pre-dominantly in unauthorized colonies. This not only causes revenue loss to the Board but such connections are also utilizing water which cannot be accounted for and also contribute to contamination.

2. It is a fact that majority of residents of these unauthorized/ illegal units are from low strata of the society/low income group. To avoid payment of development/ infrastructure charges (as applicable) and other charges in one go, the residents get tempted to go in for installation of unauthorized water connections.

3. Considering the facts, Board vide Resolution No.608 dated 09-07-2018 has accorded approval to a Pilot Scheme as under for implementation only in a selected areas under M/s. Malviya Nagar Water Services Pvt. Ltd. (PPP1) for a period of three months (upto 26-10-2018) :-

(i) Scheme for regularization of unauthorized water connections which was approved by the Board vide Resolution No.187 dated 19-03-2017 has been relaunched on same terms and conditions initially for a period of three months in whole of Delhi and therefore, would apply to this scheme also.

(ii) Pilot Scheme for Regularization of Unauthorized Water Connections and/or sanction of New Water Connections in following PPP1 areas of M/s. Malviya Nagar Water Services Pvt. Ltd. on fixed down payment and balance on instalment basis will be applicable in following 9 areas only: -

- a) Hauz Rani
- b) Mohalla Jahanpanah
- c) Kumhar Basti
- d) Neb Sarai
- e) Chirag Delhi
- f) Katwaria Sarai
- g) Lado Sarai
- h) Saidulajab
- i) Begampur Village

- (iii) Water connections would be sanctioned/regularized in aforesaid area only where technical feasibility exists i.e. water supply lines have been laid notified. No new water connection or regularization of unauthorized connection will be allowed in areas which have not been notified. However, if a water connection is found in such area, the same will be disconnected forthwith.
- (iv) For regularization of unauthorized water connection or sanction of new water connection in the aforesaid PPP areas the consumer will make down payment of Rs. 1,000/- (Rupees One Thousand Only) and balance dues will be accepted in 10 equal instalments.
- (v) This pilot scheme for payment in instalments for regularization of water connection or new water connection will be applicable only in aforesaid 9 identified colonies/areas of PPP1 as mentioned in 3(ii) above. In rest of the areas, consumers will be required to make full payment of dues, as applicable, for regularization of unauthorized water connection (under the scheme) or sanction of new water/sewer connection.
- (vi) M/s. MNWS will maintain complete record of such cases of regularization or New Water/Sewer Connections in aforesaid 9 areas and also follow up for recovery of instalments. In case of default in payment of two consecutive instalments water/sewer supply connection will be cancelled/disconnected forthwith without any further reference.

5. This Circular is being issued in anticipation of the confirmation of the minutes of the meeting of the Board.
