1. Background:

Delhi Jal Board is responsible for production and distribution of drinking water in the capital and management of sewage disposal. Delhi Jal Board undertakes various new as well as replacement works in water and sewage sector. To maintain quality of materials being used in the works, some mandatory tests are required from the laboratories which have extensive expertise and experience in carrying out testing and analysis of variety of materials with following scope of work:-

- a) To carry out destructive and non destructive testing of materials.
- b) To carry out the various chemical, Physical, Biological, Micro Biological etc. tests.
- c) To carry out testing of ferrous and non ferrous metals, cement, concrete, bricks, aggregates, HDPE pipes, polymers etc. and other building materials.
- d) To prepare the detailed test reports as per norms.
- e) To carry out the testing of materials as per the standard test methods.

2. Time period:

- a) Firm shall be registered for testing of materials for a period of 3 years.
- 3. Eligibility / Qualifying criteria to short list the laboratories:-
- a) Laboratory must be accredited with the NABL and Government approved.
- b) Laboratory or its branch must be in NCT of Delhi.
- c) Laboratory should have sufficient qualified technical, administrative and field staff.

- d) Laboratory must be ISO: 9001 certified.
- e) Laboratory must be BIS recognized.
- f) Applicant must have experience of testing of materials atleast of 5 years upto the date of issue of Expression Of Interest (EOI).

- g) Applicant shall submit details of staff engaged with their qualifications and experience.
- h) Applicant must have laboratory with well equipped modern instruments of international standard for testing and applicant shall submit the details of main equipments with their model name & year.
- i) Applicant shall submit the No. of individual tests conducted in last two years.
- j) Applicant shall submit the list of Government/Semi Government departments which are utilizing their services.
- k) Applicant shall submit the performance certificate/letters, received from the clients preferably from the Government/Semi Government/DMRC etc.
- I) Applicants shall provide an affidavit on Rs.10/- non judicial stamp paper to the effect that they have not been black listed or debarred by the Govt. and if so, the applicants will not be eligible to be short listed. Further the applicant will be excluded from the list if debarred during the period from start date of actual selection process and up to the recognition of the laboratory.
- 4. Applicants interested to be considered for short listing may apply to EE (P) Colony, DJB in writing by submitting details and documents in support of eligibility criteria, copies of registration certificates of the applicants duly signed by the authorized signatory and bearing seal of the laboratory. All the documents/certificates should be submitted as a part of EOI along with full contact address in three hard copies and one soft copy at the above mentioned address on or before 25.03.2015 by 15.00Hrs. No. application shall be received after the deadline. DJB shall not accept any explanation for any delay in transit or other reasons in receiving any EOI beyond the last date and time.
- **5.** The Expressions of Interest shall be submitted in a sealed cover, indicating therein: "Expression of interest for Recognition of Laboratories for Testing of materials being used in the works of DJB".

6. DJB reserves the right to accept or reject any or all the EOIs and reduce/enhance the scope of work without assigning any reason whatsoever. No cost shall be borne by DJB on account of submission of EOIs by the applicants under any circumstances.
