Government of India (GoI), has received a loan from Japan International Cooperation Agency (JICA) towards the cost of Yamuna Action Plan Project (III) (YAP III) through National Mission for Clean Ganga (NMCG), Ministry of Jal Shakti, Department of Water Resources, Ganga Rejuvenation and River Development, Government of India (GoI). It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for ***"Selection of Partner NGOs to carry out Public Participation, Advocacy and School Outreach Programme under Public Outreach Component for YAP-III, in specified Region of Delhi"***.

The Delhi Jal Board now invites sealed Bids from reputed registered Non-Government Organization(NGOs) including Community Based Organization(CBOs), Civil Societies and Japanese NGOs (Working in India) having experience in implementation of JICA funded projects in Disaster Management, Water Resources & Environment or similar work experience essential to conduct and carry out, "Public Participation/Advocacy and School Outreach Programme under Public Outreach Component for YAP-III".

Bidding will be conducted through local competitive bidding procedure specified in the Guidelines for Procurement under JICA ODA Loans and are open to bidders from eligible source countries as defined in the Loan Agreement. ***Single-Stage, Two-Envelope, bidding procedure will be adopted. Bidders are required to submit simultaneously two sealed envelopes, one containing the Pre-Qualification & Technical proposals in separate envelope each and other containing the price proposal. Initially, only the Pre-Qualification will be evaluated and those NGOs which pre-qualify will be eligible for evaluation of technical proposal.***
