The Government of India (GoI), has received a loan from Japan International Cooperation Agency (JICA) towards the cost of Yamuna Action Plan Project (III) (YAP III) through National River Conservation Directorate (NRCD), Ministry of Environment and Forests (MoEF), Government of India (GoI). This has now been transferred to National Mission for Clean Ganga (NMCG), Ministry of Water Resources, River Development and Ganga Rejuvenation, Government of India (GoI). It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for "Rehabilitation of sewers of sizes varying from 600mm to 1400mm Dia. in Ashok Vihar and Jahangirpuri area by Standalone Structural Lining Method under YAP (III)
2. The Delhi Jal Board now invites sealed Bids from experienced and eligible Bidders for the work of "Rehabilitation of sewers of sizes varying from 600mm to 1400mm Dia. in Ashok Vihar and Jahangirpuri area by Standalone Structural Lining Method under YAP (III) ("the Works").
3. Bidding will be conducted through the international competitive bidding procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans, and is open to all Bidders from eligible source countries, as defined in the Loan Agreement. **Single-Stage, Three-Envelope, bidding procedure will be adopted. Bidders are to submit simultaneously three sealed envelopes, one containing the "Initial Filter" for PQ, second containing Technical proposals and third containing the Price proposal. First only initial filter shall be opened and Technical Proposal of only those bidders will be evaluated who meet the eligibility criteria as annexed (6 pages).**



Qualification

(i) Exchange Rate for Qualification Criteria

Any error in determining the exchange rates may be corrected by the Employer.
