EXPRESSION OF INTEREST

The Government of India (GoI), has received a loan from Japan International Cooperation Agency (JICA) towards the cost of Yamuna Action Plan Project – III (YAP-III) through National Mission for Clean Ganga (NMCG), Ministry of Jal Shakti, Department of Water Resources, River development and Ganga Rejuvenation, Government of India (GoI). It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for ***“Selection of Partner Public Relations (PR) Agency to carry out Media Tracking and Analysis, and to assist DJB in handling, managing and improving the perceptions of the organization, publicizing its activities, policies and programs to the public at large under the YAP-III PR component, at both macro and micro levels.”***

The Delhi Jal Board now invites sealed Bids from eligible Bidders, having experience in similar to this project, – Sewage & Drainage Works, Urban Development, Water Related Projects, Environment Related Activities etc. is essential to conduct and carry out, ***“Media Relations Management activities under Public Outreach Component for YAP-III.”***

Bidding will be conducted through local competitive bidding procedure specified in the Guidelines for Procurement under JICA ODA Loans and are open to bidders from eligible source countries as defined in the Loan Agreement. A ***Single-Stage, Two-Envelope, bidding procedure will be adopted. Bidders are required to submit simultaneously two sealed envelopes, one containing the Pre-Qualification & Technical Proposals and others containing the Price Proposal. First only the Pre-Qualification will be evaluated, and those Agencies who pre-qualify only their Technical Proposal shall be opened.***
