

1. The Government of India (GoI), has received a loan from Japan International Cooperation Agency (JICA) towards the cost of Yamuna Action Plan Project (III) (YAP III) through National Mission for Clean Ganga (NMCG), Ministry of Water Resources, Ganga Rejuvenation and River Development, Government of India (GoI). It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for *"Providing & Laying 1200 mm Dia. DI Rising / Pressure Main from Bharat Nagar Wastewater Pumping Station to Common Inlet Chamber at Pitampura by Replacing one dysfunctional pumping main out of twin Rising / Pumping Mains of 1100 mm Dia under JICA assisted Yamuna Action Plan Phase-III (Package R1b)."*
2. The Delhi Jal Board now invites sealed Bids from experienced and eligible Bidders for *"Providing & Laying 1200 mm Dia. DI Rising / Pressure Main from Bharat Nagar Wastewater Pumping Station to Common Inlet Chamber at Pitampura by Replacing one dysfunctional pumping main out of twin Rising / Pumping Mains of 1100 mm Dia under JICA assisted Yamuna Action Plan Phase-III (Package R1b)."*
3. Bidding will be conducted through the international competitive bidding procedures specified in the Guidelines for Procurement under JICA ODA Loans, and are open to bidders from eligible source countries as defined in the loan agreement. **A Single-Stage, Three-Envelope, bidding procedure will be adopted. Bidders are to submit simultaneously three sealed envelopes, one containing the "Initial Filter" for Pre-Qualification, second containing Technical proposals and third containing the Price proposal. First only initial filter shall be opened and Technical Proposal of only those bidders will be evaluated who meets the eligibility criteria as annexed.**
4.
