**EXPRESSION OF INTEREST (EOI) DOCUMENT**

Delhi Jal Board, invites 'Expression Of Interest' (EOI) from the consulting firms/agencies to provide consultancy services for the work of **"Rehabilitation of Sewage Pumping Stations (SPSs) feeding to Sewage Treatment Plants ( STPs) at Rithala Ph-I, Kondli and Okhla including major Rehabilitation of E&M Equipments with LLC concept to increase Operational & Maintenance Efficiency of these SPSs of these SPSs, Strengthening/Rehabilitation of Rising Main and Civil Structure so as to maximize utilization of above STPs after their Rehabilitation under YAP-III "**.

1. **Background:** The Sewage Treatment Plants under Delhi Jal Board at Rithala -Ph. I, Kondli and Okhla are to be Rehabilitated under Yamuna Action Plan (YAP)-III. To optimize the capacity utilization of these STPs and to maximize the quantity of sewage inflow to these STPs, the Terminal SPSs feeding sewage to these STPs need to be Rehabilitated along with the allied works. As such, following is the STP –wise list of Sewage Pumping Stations (SPSs) which need to be rehabilitated :-

2. **Scope of work:-**

- To study all the SPSs in catchment of these three STPs i.e., Rithala Ph-I STP, Kondli STP and Okhla STP and to assess the status of Electrical & Mechanical equipment installed in these SPSs and their Civil Structure as well as rising mains.

- Preparation of Specifications of works, Engineer's estimate based on extent of Rehabilitation required in these SPSs and to carry out detailed Engineering.
  - Preparation of Tender Documents including drawings for Civil, Mechanical and Electrical & Instrumentation works to be carried out.
  - Invitation of Bids.
  - Evaluation of Bids & Preparation of Bid Evaluation Reports.
  - Supervision and Monitoring of works, including checking of structural and other Equipments related drawings and designs to be submitted by the Contractors till completion of trial run and commissioning.
  - Preparation of Manual Documents for Operation & Maintenance of these SPSs
3. Following Eligibilities/Qualification criteria will be used to shortlist the Consultants:-
- The applicant may be an independent single firm or a joint venture with other firms.
  - The intending firm or in case of joint venture, the lead partner should have experience in project of similar complexity and technical speciality in India/Developing/developed Countries.
  - In case of joint venture firms, it must be clearly indicated /stated in the EOI that who the "Lead Partner" is. The lead partner must possess similar experience and technical expertise in areas relating to this project. International Consultants shall have their office in India and can submit their offer in the name of Indian office or as a joint venture with other local firms having adequate experience and resources to offer consultancy of such an extent, if desired.
  - Experience in providing Consultancy for project Management of similar projects Work.
  - The intending firm should have an average annual turnover of Rs 3 crore (Rupees Three Hundred lakh) for the last three years ending March 2012.
  - The intending firm has to be profitable and should not have incurred loss in the three financial years ending March 2012.
  - The intending firm should have completed similar consultancy assignment involving Sewage Pumping Stations(Rehabilitation & New) of at least totalling 100MGD capacity & 4000 meters of Rising Main (Rehabilitation/New) in the last 10 years.
4. The interested firms may submit their EOI application to EE(SDW)XIV, DJB in writing about their technical capabilities by providing the following information , which will be used to shortlist the consultants:-
- List of similar assignments completed successfully especially SPSs (Rehabilitation /New with rising main), with brief project description, relevancy, and information regarding cost of the services, cost of project and employer in the last 10 years.
  - List of similar assignment in progress with brief project description, relevancy, and information regarding cost of the services, cost of project, employer and funding agency.
  - Company profile and the list of relevant skills with the staff and their indicative Curriculum Vitae.
  - Project delivery capability in India and abroad (if any).
  - Company registration Certificate/s and Document/s.
  - Latest Annual Report and audited and accounts.
  - Document/s clearly showing last three (3) years annual turnover figures.
  - Eligibility statement.
5. Only eligible firms having the required qualification shall be considered for short listing and only the shortlisted firms or associations shall be issued Request for proposal (RFP) document for submission of their proposals.

6. Consulting firm barred from participating in any Govt. project or Blacklisted in any Department of Government of India on the date of submission of their EOIs, will not be eligible to participate in this project. A declaration to that effect shall be furnished by applicants that the firm is not blacklisted in any deptt. /organisation as stated above.
7. No application shall be received after the time deadline mentioned in the 'Notice Inviting Expression of Interest 'for this work.
8. DJB shall examine the proposals and evaluate them as per information and documents submitted by the consultants/firms to short list the consultants. However, DJB reserves the right to accept or reject any or all of the EOIs without assigning any reason whatsoever.
9. DJB shall not accept any explanation for any delay in transit or any reasons in receiving any EOI beyond the last date and time as mentioned in this invitation notice. The responsibility of ensuring that expression of interest is received before the time and dates specified, shall rest with the consultant and no responsibility in this regard shall be upon DJB for late entries.
10. DJB reserves the right to reject any or all of the Applications submitted in response to this Expression of Interest Document at any stage of the process without assigning any reasons whatsoever. DJB also reserves the right to with-hold or withdraw the process, cancel or modify the process or change/modify/amend any or all provisions of this Expression of Interest Document without assigning any reason whatsoever at any stage without intimation to all who submitted the Expression of Interest Application.
