Empanelment of Agencies for providing hired tankers to transportation the treated effluent from various Sewage Treatment Plants of Delhi Jal Board

Delhi jal board is operating 34 nos. of Sewage Treatment Plant throughout Delhi region having capacity of (approx) 600 MGD. To encourage water conservation and for utilization of treated effluent of sewage treatment plant for non portable purposes like horticulture, washing of vehicles, industrial use, construction activities & flushing in toilets etc. the DJB has taken initiative and started sale of treated effluent at very nominal charges @ Rs. 7/KL through tankers. For this purpose Filling Points are available at all the Sewage Treatment Plants with round the clock operation. The brief details of STPs along with treated effluent quality parameters are as follows:-

For supply of treated effluent in Delhi and NCR region through Tankers DJB invites Expression of Interest (EOI) from reputed agencies/contractors for empanelment.

Scope of Work:-

The Scope of work will include but not limited to the following:-

1. The water tanker container shall be painted with **yellow colour** duly marked with (the precaution) in **Red colour "Water is not fit for Drinking Purpose"**.
2. The capacity of tankers is also to be mentioned on tankers with bold letters.
3. The tanker should not have any leakage through its body or any valves.
4. All mandatory certificates for vehicle registration & fitness of vehicle etc. should be available.
5. The vehicles must be fit for operation in Delhi & NCR region in line with the orders of Hon'ble NGT.
6. The driver should have valid Driving licence of heavy vehicles and minimum 2 years driving experience in Delhi / NCR.
7. The use of alcohol, cigarette & tobacco is prohibited inside plant premises.
8. In case of any accident inside or outside the plant the agency shall be responsible for the same and will bear the entire cost of any damage.
9. The tankers should not be used to transport potable water.

1. The interested agencies/contractors may provide their complete profile, registration certificate, work experience, list of present clients and details of Numbers of tankers along with capacity.
