### 1. INVITATION TO EOI

The Delhi Jal Board invites Expression of Interest for sale of Bio Gas coming out from Sewerage Treatment plant(STP) of 12 + 20 +40 MGD at Keshopur.

### 2. SCOPE OF WORK

2.1. The firm has to utilize the Bio-gas for power generation, converting in to CNG or any other use as suitable to them. There shall be no expenditure borne by DJB.

2.2. Construction period of the installation is 12(Twelve) month and Operation & maintenance of the installation for a period of Ten years [10 years]

# 3. ELIGIBILITY OF BIDDERS

3.1. The EOIs proposal for this work shall be considered only from those bidders (proprietorship firms, partnerships firms, companies, corporations, consortia or joint ventures) who have the relevant experience as per their utilization.

## 4 Pre-Bid Meeting:-

Pre-bid meeting shall take place with the prospective bidders before submission of EOIs in the office of the SE(SDW)-III W.S.T.P. Keshopur(Opp. DTC Depot keshopur) New Delhi-110018. The prospective bidders desire to take part in pre-bid meeting in person or through written queries shall be required to send their queries (alongwith its soft copy at sesdw3@gmail.com/eesdw06@gmail.com), if any, with regard to EOI documents, on or before the date fixed for pre-bid meeting. ### 6 Bidder to be Fully Conversant

The bidder shall be deemed to have satisfied himself as to all the conditions and circumstances affecting the, as to the general circumstances at the Site of the work and as to general labour position in his own views. The Bidder shall be responsible for any misunderstanding of information given in writing by the DJB or fails to interpret the clauses/ specifications.

### 7 Evaluation of EOI

a. The Delhi Jal Board reserves the right to reject any or all the EOIs without assigning any reason.

b. The Delhi Jal Board, if needed, will obtain clarifications by requesting such information from any or all the Bidders in writing as may be necessary. The Bidders will not be permitted to change the substance of his EOI after it has been opened. Non-compliance with this provision could be a cause for disqualification.

c. In comparing the EOIs, the Delhi Jal Board will consider such factors as compliance with the EOI Specification, past experience, after sales service facilities and the Bidder's capacity to perform shall form the basis of evaluating the offer. In addition, specific aspects, if any, mentioned elsewhere in EOI Specifications will also be considered.

### 8 Documents

# SCOPE OF WORK & RESPONSIBILITY OF THE COMPANY/PARENT CO.

Expression of Interest/Request for Proposal for purchase of Bio Gas coming out from Sewerage Treatment plant(STP) of 12 + 20 +40 MGD at Keshopur.

- The firm has to utilize the Bio-gas for power generation, converting in to CNG or any other use as suitable to them. There shall be no expenditure borne by DJB.
- Firm /Company will have to buy the entire quantity of crude Bio Gas (with minimum gas available of appx. 7000 to 8000 cum. ) as it is.
- 3. Firm /Company will install/commission the project within 12 months after award of contract from DJB and operate the same for a period of 10 years. The period of Contract may be further continued for 5 years for same terms & conditions if agreed by both sides. Firm/Company will develop all infrastructures by its own funds at land provided by DJB if required.
- Firm/Company will require an electric connection to run this project, the cost and bills will be paid by the concerned firm/ company.
- Firm/Company will take all necessary clearances/licenses from different govt. Departments such as DPCC, CPCB, etc. required to set up and run this project on its own cost DJB will support to concerned firm/company for such clearances/licenses.
- 6. Firm /Company shall comply all govt. Rules and regulations, required to set up and run such project.
- 7. Firm/Company will establish the project as per National standard of renewable project and will be environment friendly, which will not emit any harmful gases and liquid.
