



1. India has applied for financing from the Asian Development Bank (ADB) toward the cost of **Delhi Water Supply Improvement Investment Program - Tranche 1**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of the ADB.
2. The **Delhi Jal Board** (the “Employer”), represented by the Project Manager, DWSIIP, invites sealed bids from eligible Bidders for the *Distribution Network Improvement in UGR Command Areas Punjabi Bagh (G-02), Pitampura (H-06) and Lawrence Road (H-08), Targeting Continuous Pressurized Water Supply and DMA Based NRW Reduction and Providing House Service Connections*. The detailed scope of work is provided in Section 6, Employers Requirement. The scope of work also includes design-build period of 4 years and operating and maintaining the system for a period of 10 years, post construction.
3. Only eligible bidders with the following key qualifications should participate in this bidding:
