- The above said regulations, application Performa, Terms & Conditions of Licence and notified sites for disposal of waste can be downloaded from Delhi Jal Board website [www.delhijalboard.nic.in](http://www.delhijalboard.nic.in) or may be obtained from the designated DJB office.
- The applicant must reach the designated office of DJB within one month.
- It may be noted that undertaking this task without a valid license or/and dumping the septic tank waste at any non-designated location will be punishable as per law.

# **Delhi Water Board Septic Tank Waste Management Regulations 2015**

In exercise of powers conferred by Section 109 of the Delhi Water Board Act, (Act No. 4 of 1998), the Board hereby makes the following Regulations, for collection, transportation and disposal of waste of septic tanks and for matters connected therewith and incidental or ancillary thereto.

## CHAPTER – I

1.

- (a) These regulations may be called ‘Delhi Water Board Septic Tank Waste Management Regulations 2015’
- (b) These Regulations shall come into force from the date of its issuance by the Board and subject to Section 109(3) of the Delhi Water Board Act 1998.

## 2. **Definitions:**

- (i) ‘Act’ means the Delhi Water Board Act, 1998 (Delhi Act N0. 4 of 1998);
- (ii) ‘Board’ means the Board as defined in the Act;
- (iii) ‘CEO’ means the Chief Executive Officer of the Board;
- (iv) “Drain” means a line of pipes including all fittings and equipment such as manholes, traps, gullies and floor traps used for the drainage of one building, or any buildings or yards appurtenant to the building, within the same curtilage and includes a house drain.
- (v) “Licensee” means a written permission granted for this purpose to any person, having mentioned the purpose, period, name and address, route etc. under the signature of the authorized signatory of the DJB.
- (vi) “Manhole” means an opening by which a man may enter or leave a sewer or other closed structure for inspection, cleaning and other maintenance operations, fitted with a suitable cover.
- (vii) “Notified location” means the location of delivery and disposal of septage as defined and earmarked by DJB
- (viii) “Septage” means fecal sludge produced in septic tanks.
- (ix) “Septic Tank” An underground tank that treats wastewater by a combination of solids settling and anaerobic digestion. The effluents may be discharged into soak pits or small bore sewers and the solids have to be pumped out periodically.
- (x) “Sewers” means conduits provided for the purposes of carrying the liquid wastes of the community, otherwise known as sewage or sludge.

- (xi) “Sewage pumping station (SPS)” means the pump house of Delhi Jal Board from where sewage is pumped to a desired location.
- (xii) “Sewage Treatment plant (STP)” means the place where sewage is treated by Delhi Jal Board.
- (xiii) “Sludge” means the settled solid matter in semi-solid condition, it is usually a mixture of solids and water deposited on the bottom of septic tank ponds etc. The term sewage sludge is generally used to describe residuals from centralized waste water treatment while the term septage is used to describe the residual from septic tank.
- (xiv) “Registered Vehicle’ means a vehicle due registered by the Transport authority of the state to perform the designated purpose.
- (xv) “Treatment” means any method technical or process design to alter the physical, chemical or biological and radiological character or composition of any waste or waste water to reduced or prevent pollutions.

All other words and expressions used in these regulations and not defined in these regulations and not defined herein but defined in the Act shall have the meaning respectively assigned to them under the Act of or in absence thereof, the meaning as commonly understood in the water supply and sewage treatment / disposal industry.

## CHAPTER-II

### LICENCE FOR COLLECTION AND TRANSPORTATION OF SEPTAGE

#### 3. **Licence to be issued by the Board.**

CEO will authorize officer(s) of the Board to issue licence for collection and transportation of septage to notified locations.

- (i) Licence will be issued in the format prescribed in Annexure -1 of these regulations and will be valid for a period of two years from the date of issue, unless revoked earlier.

#### 4. **Criteria for issue of Licence**

(a) The applicant should own leak-proof, odour and spill proof transporting vehicle (s) with a proper vacuum/ suction and discharging arrangement.

The vehicle should have a valid permit of the Transport Department to operate in Delhi.

The applicant should have staff adequately trained for this purpose.

The staff should be equipped with safety gears and other protective equipment required to safely collect, transport and dispose of the septage at the notified locations.

#### 5. **Application for Licence**

The application for obtaining licence for collection, transportation and disposal of septage shall be submitted in such format and with such documents as prescribed by the CEO.

#### 6. **Invitation of applicants to apply for licence.**

Delhi Jal Board shall give wide publicity on its web site and through newspapers and other media inviting prospective applicants to apply for the licence.

#### 7. **Fee for the Licence**

Delhi Jal Board shall charge an amount of Rs. 1000/- (Rupees one thousand) as application fee for processing the application for grant of licence. The fee will be non-refundable. The fee can be paid electronically or by Demand Draft in favour of Delhi Jal Board.

#### 8. **Performance Guarantee.**

The Licensee shall deposit with the Board Performance Guarantee of Rupees Ten Thousand which shall be forfeited in case of any violation.

#### 9. **Publicity of the licenced agencies.**

The Board will give wide publicity to the agencies who have been granted licence under these regulations to undertake the work of collections & transportation of septage.

#### 10. **Awareness Campaign**

The Board will undertake an awareness campaign to make the people aware of these regulations as well as the need to engage only the licenced agencies for collection, transportation and disposal of septage.

### CHAPTER-III

#### 11. **COLLECTION AND TRANSPORTATION OF SEPTAGE**

Only licenced agencies to collect and transport septic tank waste. Septic tank waste shall be collected and transported only by an agency having a valid licence for this purpose issued by the Delhi Jal Board in the format prescribed at Annexure-1 of these regulations.

#### 12. **Owner/occupier of building to engage only licenced agency.**

- (a) It shall be the duty of each owner/occupier of the building to engage the services of only those agencies which have been issued licence by the Board for collection and transportation of septage.
- (b) The owner/occupier shall confirm that the licence issued to the agency is valid on the date of execution of work. She/he shall also append her/his signature to the collection and transport record form prescribed at Annexure-2 of these regulations.

#### 13. **Fee for Collection/Transportation of septage.**

- (a) The fee for collection and transportation of Septic Tank Waste upto notified locations at SPS/STP shall be as prescribed by the CEO from time to time.
- (b) No licensee shall charge any amount from the owner/occupier of the building in excess of the prescribed fee.
- (c) Any demand for fee for collection and transportation of septage in excess of the fee prescribed by the CEO shall make the licensee liable for cancellation of licence and imposition of penalty prescribed for violation of these regulations.

#### 14. **Vehicles for Transportation of Septage**

The Septage shall be transported only in the vehicles approved for this purposes by the officer authorized for this purpose by the CEO.

#### 15. **Precautions during Transportation.**

The licensee shall ensure that there is no leakage of the septage during transportation from the collection point to the notified location for disposal.

#### 16. **Preventive measure in case of accident.**

The vehicle carrying septage shall be fitted with prescribed equipments to take care of threat of pollution due to any accident during the movement of the vehicle from Collection point to the notified disposal location.

#### 17. **Full liability of licensee in case of accident.**

The licensee shall be fully and completely liable for any damage to any person, vehicles, property and environment in case of any accident or disaster.

18. **Safety measure for the staff deployed.**

The licensee shall be responsible for taking all the safety measures including provision of hand held gas detectors, gas masks, protective gear, oxygen mask with oxygen cylinder and first aid box etc. and such other measures as prescribed by the officer authorized by the CEO for grant of licence for the people deployed for collection and transportation of septage.

19. **Disposal of Septage.**

(a) The licensee shall dispose of septage only at the locations notified by the Delhi Jal Board.

(b) The licensee shall submit the septage collection and disposal form prescribed at Annexure -2 of these regulations duly filled up with factual details to the official of the Board deployed to receive the septage at the notified locations.

20. **Training of Staff.**

The licensee shall be responsible for regular training of the staff deployed in collection, transportation and disposal of the septage use of protective equipment for taking measures to minimize the damage to the environment in case of an accident.

21. **Regular Health Check up of staff**

The licensee shall be responsible for ensuring that every person deployed under goes health check-up at least once in every year and submit record of the same to DJB at the time of renewal of licence.

22. **Insurance**

The staff deployed by the licensee shall be insured for accident during the process of cleaning, transportation and disposal of septage.

23. **Cancellation of licence.**

In case of violation of any of the provisions of these regulations the licence shall be liable to be cancelled, security of the licensee shall be forfeited and he shall also be liable to pay penalty as prescribed for violation of these regulations.



## CHAPTER IV

### Disposal of Septage

24. **Identification of Disposal Sites**

The CEO will identify and notify the Sewage Pumping Stations or/and Sewage Treatment plants where the septage can be deposited by the licenced agencies.

25. **Creation of Infrastructure to receive the septage.**

At the notified locations, the Board will create necessary infrastructure and provide necessary equipments so that septage brought by the licenced agency can be received and disposed of in a proper manner.

26. **Deployment of staff to receive the septage**

The Board shall deploy staff at each notified location, sufficient and trained staff to receive the septage and dispose it off through the Sewage Treatment Plants or/and Sewage Pumping Stations as the case may be.

27. **Timing to receive the septage**

The septage will be received by the officials of the Board at each notified locations on all days from 7.00 a.m. to 7.00 p.m.

28. **Industrial Waste not to be received.**

The Board shall not receive any septage containing the industrial waste at any of the notified locations.

29. **Training in Septage Management**

The Board's staff deployed at the notified locations will be trained for receiving and disposed of septage.

## CHAPTER V

### MISCELLANEOUS

**30 Display of licence and colour coding on the vehicle**

(a) A copy of licence shall be prominently displayed on the vehicle used for transportation of septage.

(b) The vehicle/ container/tanker shall be painted with Yellow colour duly marked with (the precaution) in Red Colour “SEPTIC TANK WASTE” (in English) and “३३३३३३” (in Hindi).

**31 Installation of GPS system**

Each vehicle used for transportation of septage shall be fitted with GPS device and access rights of the same shall be given to the Board and the agency notified by the CEO for tracking of such vehicles.

## **TERMS AND CONDITIONS**

### **1. Licence to be issued by the Board.**

Chief Engineer (E&M) Planning has been authorized by the Board to issue licence for collection and transportation of septage to notified locations.

- (i) Licence will be issued in the format prescribed in Annexure -1 of these regulations and will be valid for a period of two years from the date of issue, unless revoked earlier.

### **2. Criteria for issue of Licence**

(a) The applicant should own leak-proof, odour and spill proof transporting vehicle (s) with a proper vacuum/ suction and discharging arrangement.

The vehicle should have a valid permit of the Transport Department to operate in Delhi.

The applicant should have staff adequately trained for this purpose.

The staff should be equipped with safety gears and other protective equipment required to safely collect, transport and dispose of the septage at the notified locations.

### **3. Fee for the Licence (for each vehicle)**

Delhi Jal Board shall charge an amount of Rs. 1000/- (Rupees one thousand) as application fee for processing the application for grant of licence for each vehicle. The fee will be non-refundable. The fee can be paid electronically or by Demand Draft in favour of "Delhi Jal Board".

### **4. Performance Guarantee (for each vehicle)**

The Licensee shall deposit with the Board Performance Guarantee of Rupees Ten Thousand (for each vehicle) which shall be forfeited in case of any violation.

### **5. Collection and transportation of septage**

Only licenced agencies to collect and transport septic tank waste. Septic tank waste shall be collected and transported only by an agency having a valid licence for this purpose issued by the Delhi Jal Board in the format prescribed at Annexure-1.

In case of any violation to the above, the agency undertaken such work without a valid licence from DJB shall be liable/punitive action by the concerned authority(s).

### **6. Owner/occupier of building to engage only licenced agency.**

- (a) It shall be the duty of each owner/occupier of the building to engage the services of only those agencies which have been issued licence by the Board for collection and transportation of septage.

- (b) The owner/occupier shall confirm that the licence issued to the agency is valid on the date of execution of work. She/he shall also append her/his signature to the collection and transport record form prescribed at Annexure-2.

7. **Fee for Collection/Transportation of septage.**

- (a) The fee for collection and transportation of Septic Tank Waste upto notified locations at SPS/STP shall be as prescribed by DJB from time to time.
- (b) No licensee shall charge any amount from the owner/occupier of the building in excess of the prescribed fee.
- (c) Any demand for fee for collection and transportation of septage in excess of the fee prescribed by the CEO shall make the licensee liable for cancellation of licence and imposition of penalty prescribed for violation of these regulations.

8. **Vehicles for Transportation of Septage**

The Board shall deploy staff at each notified location, sufficient and trained staff to receive the septage and dispose it off through the Sewage Treatment Plants or/and Sewage Pumping Stations as the case may be.

20. **Timing to receive the septage**

The septage will be received by the officials of the Board at each notified locations on all days from 7.00 a.m. to 7.00 p.m.

21. **Industrial Waste not to be received.**

The DJB staff shall not receive any septage containing the industrial waste at any of the notified locations.

22. **Display of licence and colour coding on the vehicle**

(a) A copy of licence shall be prominently displayed on the vehicle used for transportation of septage.

(b) The vehicle/ container/tanker shall be painted with Yellow colour duly marked with (the precaution) in Red Colour "SEPTIC TANK WASTE" (in English) and "३३३३३३" (in Hindi).

23. **Installation of GPS system**

Each vehicle used for transportation of septage shall be fitted with GPS device and access rights of the same shall be given to the Board and the agency notified by the CEO for tracking of such vehicles.

## 24. **Application for Licence**

Similarly, the duly filled up forms along with the required documents and fee can be deposited with any offices of DJB where the photocopies of documents attached will be compared with the corresponding original documents.

After approval of the Nodal authority i.e. CE (E&M) Planning DJB, the Licence will be sent to the Postal address of the applicant and will also be uploaded on the DJB website from where it can be downloaded.

- ix) Performance guarantee in form of Bank Guarantee (valid for three years) in favour of CEO Delhi Jal Board amounting to Rs 10000/- ( Rupees Ten Thousand) only per vehicle issued by any Nationalised Bank.
